ACT:

The next ACT test date is December 9th - Registration deadline is Friday, Nov. 3rd

---Seniors, this will be your last testing chance before most schools' academic scholarship deadlines. --- *Some schools allow you to submit test scores after the scholarship deadline. Look into that, especially if you are close to the next tier of scholarship dollars your school awards. Could be be worth one more attempt at raising your ACT score/scholarship amount!

ROTARY SCHOLARS: Be sure you are keeping up with your online GEN ED 100 assignments. If you need to drop the course, contact April Smith (april.smith@kctcs.edu) Remember that passing the course with a C is a requirement for the Rotary Scholars Program (free tuition for 2 years – HCC). If you dropped in the fall or have decided you'd like to enroll for the spring course, the time to do that is now.

DUAL CREDIT STUDENTS: Registration took place last week for the Spring Semester. If you feel changes need to be made, that needs to be taken care of ASAP as some courses quickly reach their max number of students. Reminder that your dual credit scholarship will cover one course, the cost for an additional course is \$279. Some courses may also have a book or class fee as well.

All balances for the fall semester are past due, please be sure you go to your account through your blackboard to make payments if you haven't already done so.

To apply, go to www.khsaa.org/ge83-agriculture-athlete-of-the-year-scholarship-application/ High school graduating senior, Must be a Kentucky farmer or involved in agriculture, Participate in one or more KHSAA sports or sport activities during the 2023-2024 school year Minimum GPA of 2.0 . (4) \$1,000 scholarships to two male and two females athletes who are chosen as the Kentucky Ag Athletes of the Year and (2) \$2,000 scholarships will be awarded to one male and one female overall winners as the Outstanding Kentucky Ag Athletes of the Year.

COLLEGE NEWS:

At this point, you should be working on college applications and submitting those along with supporting documents: transcripts, ACT scores, letters of recommendation. **Colleges require separate academic scholarship applications.** You should be working on these also, as many schools have academic scholarship deadlines around Dec. 1st, some January 15th. HOWEVER, many schools are backing up their deadlines considerably, as in November scholarship deadlines. **Be sure to check out deadlines specific to your chosen school.**

You have to be admitted to the university first to be granted scholarships within the school. Most universities give a general rule of thumb that it will take 2-4 weeks to process your application and issue admittance letters. So NOW is the time to submit your college applications IF you plan on applying for academic scholarships.
