Data Collection and Usage

Information that you give to us

When you register for and use our services we collect the information that you give to us. This may include information like your name, email address, phone number, date of birth, country of residence, language, gender, and time zone.

Information we collect when you use our services

We also collect and process information about your use of our services. This can include information about your device, your location, your interaction with our services and other Girls Glimpse users, your content and your purchases.

Information about your device

When you use our services we may collect specific information about your device, and across your devices, such as the product model, serial number, operating system, device settings, device performance, Internet service provider, IP address and other unique identifiers.

Information Collected by Third Parties through Third Party Links and Content The Service may include links to other websites and other content from third party businesses. We do not have access to or control over the technology that these third parties may use. We are not responsible for the privacy practices of these third parties or the content on any third party website. You are encouraged to review the privacy policies of the different websites you visit and of the advertisers whose ads you may choose to click while on our Service.

How We Use the Information We Collect.

We use the information we gather through the Service to help us better understand how the Service and our products and services are being used. By identifying patterns and trends in usage, we are able to better design the Service and our products and services to improve your experience.

We may use cookies, or other similar technologies, on some of the features of our services. Cookies are small files that are typically downloaded to the browser application on your device. Cookies help us to ensure the safety and smooth functioning of certain features of our services and they also help us to collect information about your user preferences. We sometimes use information collected from cookies to improve your user experience and the quality of our services. For example, by saving your user preferences, we may be able to customize our services in ways that you prefer. You may be able to disable cookies in your browser settings or set your browser to alert you when cookies are being used. If you disable cookies, you may not be able to use all of the features of our services. Some web browsers may transmit "do not track" signals. We currently do not take action in response to these signals.

Tracking

Girls Glimpse augments its services with some Google Play Approved Third Party Analytics Service Providers. We use the analytics provided from these services to improve our games and our ad experience.

Some of the services we implement with these analytics include Impression reporting, integration with DoubleClick, Remarketing and Demographic and Interest reporting. This information is not combined with any personal information you may have submitted to us.

You can also disable cookies via your browser settings. Our systems do not acknowledge Do Not Track Signals.

Profile Creation:

Girls Glimpse allows the creation of an optional profile to access additional features in the game. These features may include joining a public leadership or user-to-user interactions.

The creation of these profiles is completely optional and is confirmed by the user through in app dialogues. The creation of profiles may require additional information such as a username and age. This information might be public and visible, but can be controlled by the user and consent for these profiles can be withdrawn at any time.

Payment Information:

Our games and applications may have optional in app purchases. A purchase may be initiated by the user, or by a legal guardian of the user if the user is a minor. To complete a transaction, several details such as the Name, Billing and Payment Addresses and Complete Credit Card Information needs to be provided by the user to the payment processing partner, which is used to complete the payment

Our ads contain content that is appropriate for the specified audience. We do not display personalized ads in our games designed for families.

Data Security

Girls Glimpse takes steps to ensure the physical and digital security of its data.

Girls Glimpse makes sure only authorized personnel have access to the data, and can only access it when they have a need to access it to complete relevant work. Data stores with us are placed behind firewalls.

If we have to share our data with a third party we make sure they have similar Privacy Policies in place.

All reasonable measures are enforced to ensure data security.

How your information is shared

We sometimes share your information within our family of Girls Glimpse companies and with trusted third-party partners outside of Girls Glimpse. We may also share your information for other legal and business purposes, such as complying with legal processes, responding to claims or inquiries, enforcing our terms, or protecting the rights, property or personal safety of our operations, our users, or the public. The use of your information, and the use of cookies, web beacons, or other technologies, by these third-party providers is subject to their own privacy policies.

If you opt in to receive marketing communications from third parties, we may, from time to time, share the information you provide to us with selected third party marketing partners that we believe offer products or services that may be of interest to you. Our Data Retention and Deletion Policy

We treat all personal information obtained through users with contact with the highest confidentiality. This may include email addresses shared with us to help assist with issue resolution.
