# Shared Repositories Infrastructure Advisory Committee (SRIAC) Terms of Reference

#### **Purpose**

The role of SRIAC is to provide CARL directors and those working on the shared repositories project with guidance and recommendations for strategies specific to shared digital repository hosting and technology infrastructure. The shared repositories initiative supports a vision of "advancing national open infrastructures," to ensure Canadian research institutions have access to sustainable digital repository platforms that can be shared for common purposes, and with a goal of making the most of collective and institutional resources.

## Responsibilities

SRIAC is expected to offer guidance in the following areas:

- Advising CARL and the project director on use cases, platform selection criteria and priorities, implementation path, timelines, organizational and financial sustainability models, and other areas that support the success of the project.
- Identifying practical and timely strategies for hosting and platform support
- Leveraging existing infrastructure and investment in operating at scale (national or otherwise) with mission and sustainability in mind
- Identifying integration or bridging opportunities where shared repositories can support standards-based practices, e.g., PID adoption, discovery and indexing, long-term preservation.

## Reporting

Reporting to the Advancing Research Committee (ARC) and working closely with the Project Director for National Shared Repositories Infrastructure, the committee will operate until August 2023, at which time the mandate and scope will be reviewed.

Respectful of time, the committee is anticipated to meet monthly with the possibility of task work and communications occurring between meetings.

for members to comment on and provide feedback. The committee will provide advisory guidance and feedback to the project director in support of achieving the project's goals.

CARL will set up a mailing list for the advisory members to communicate internal committee business (use PROJA-CARL-L@LISTSERV.UOTTAWA.CA). To ensure progress and updates are shared with the broader CARL+ community, CARL-L and REPOS-L will be used for wider information sharing.
