Abstract

Abstracts are written in 2 languages, namely English and Indonesian. Writing abstract title using bolds for abstract substance written Book Antiqua, 10 pt, italic, 1 space, max 250 words. Abstract contains: the purpose of the study, the writing method, the results/findings of the study. Keywords can be written in the form of "words" or "phrases" Keywords consist of 3-5 words or 3-5 phrases

Article Type

Articles are original articles of research results or review results from previous articles. Articles only can be written in English. The number of article pages is *no more than 20 pages*, including references. The systematic writing of the research article consists of title, author's name, institution and correspondence address, abstract, keywords, abstract, keywords, introduction, methods, results and discussion, conclusions and suggestions, gratitude and reference list (Wahyuni et al., 2018; Suparman, 2012). The systematic conceptual article writing (containing the results of the review) consists of the title, author's name, institution and correspondence address, abstract, keywords, abstract, keywords, introduction, core part, summary and list of references.

The manuscript is written using Book Antiqua letters, size 11, space 1 and line spacing 1 cm. Text is typed in a print area with *margins* from top, bottom, left, right made *3cm*. A4 paper size, 8.27-inch-wide, 11.69 inch high. Layout: 0.5-inch header, 0.5-inch footer.

I. Introduction

The Introduction section is written in a clear manner that contains an adequate background of the problem, the problems studied, the purpose of writing, and *the state of the art* of previous research and publications, as proof that the proposed article has originality and has a new contribution to scientific contributions that are important to be published. The introduction also contains an explanation of the *gap* analysis and or urgency of the study compared to previous studies. For this reason, it is necessary to state the novelty of the scientific study being carried out. The statement of novelty is strengthened by a literature review of previous studies. The source of *the state of art* is recommended from primary sources, namely relevant journal references and recent publications in international and national journals.

2. Method

Articles that are sourced from research results, research methods are written as a separate chapter after the Introduction chapter. The research method contains the type of research, method of approach, sources of legal materials and data sources, legal material collection techniques, data collection techniques, and methods of analyzing legal materials and data analysis. For conceptual idea articles, it is sufficient to discuss only the method of study approach which is placed at the end of the Introduction chapter.

Research Methods writing sample.

This paper uses a normative legal research method because the focus of the study departs from the vagueness of the norm, using the approaches: *statute approach*, *conceptual approach*, and *analytical approach*. The legal material search technique uses document study techniques, and the study analysis uses qualitative analysis.

Other sources (40%) can be books or other reference sources. References used as citations are written in the Bibliography, and are *arranged alphabetically* by the author.
