Notice of Race (NoR)

1. RULES

- 1.1. The event is governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2. The prescriptions of the Royal Yachting Association (RYA) will apply.
- 1.3. The Organising Authority implements the Royal Yachting Association (RYA) Racing Charter. Competitors shall undertake to sail in accordance with the Charter (<https://www.rya.org.uk/racing/rules/racing-charter>).
- 1.4. The current International Hansa Class Rules for each class will apply (<https://www.hansaclass.org.uk/spage-meetings-documents.html>).
- 1.5. HCUK current Special Class Rules will apply (<https://www.hansaclass.org.uk/spage-meetings-documents.html>).
- 1.6. The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).
- 1.7. RRS Appendix T (Arbitration) will apply.
- 1.8. [DP] RRS 40.1 applies at all times while afloat.
- 1.9. RRS 63.7 is changed so that in the event of a conflict between the Notice of Race and Sailing Instructions, the Sailing Instructions shall prevail.
- 1.10. If there is a conflict between languages, English text will take precedence.

2. SAILING INSTRUCTIONS

- 2.1. The sailing instructions will be available on the official notice board at least three days prior to the event.
- 2.2. Individual copies of the sailing instructions and ESS will be provided on request to competitors at registration.

3. COMMUNICATION

- 3.1. The official notice board will be displayed in the entrance hall to the sailing club.
- 3.2. Additional information pre-event will be communicated directly with sailors via email.

4. ELIGIBILITY AND ENTRY

- 4.1. The event is open to all boats of the Hansa 303 Class, solo and double.
- 4.2. Solo and double classes will race at separate times and competitors are encouraged to enter both classes to maximise their time on the water.**
- 4.3. Eligible boats may enter by filling out the form at <https://events.hansaclass.org.uk/>
- 4.4. To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees. The fees can be paid on the event registration page.
- 4.5. The closing date for entries is midnight on Sunday 29th June 2025. Entries after this date are at the discretion of the Organising Authority, contact rorymckinna947@gmail.com to request a late entry.
- 4.6. A Parent/Guardian Consent and Supervision Form must be completed by the Parent or Guardian of any competitor under the age of 18 on the first day of the event. This forms part of the online entry.

5. FEES

- 5.1. The entry fee is £30 per person. Competitors who enter in the single **and** double class only have to pay **one entry fee**.
- 5.2. The entry fee includes mooring and 1 dinner (BBQ) on Saturday evening.
- 5.3. An additional fee of £10/day will be required for use of charter boats.
- 5.4. 6 Hansa Class UK boats will be available and can be booked through the entry page.
- 5.5. Additional local boats can also be booked. Email rorymckinna947@gmail.com for details.

6. ADVERTISING

- 6.1. Boats may be required to display advertising chosen and supplied by the organizing authority.

7. SCHEDULE

7.1. Registration:

Two extra races per day may be sailed, provided that no class becomes more than one race ahead of schedule. This change of schedule will be made according to SI 2.

7.4. The scheduled time each day:

7.5. On the last scheduled day of racing no warning signal will be made after 16h30. A warning signal can be made after 16h30 after a general recall or a delay in the procedure for a race with a warning signal before 16h30.

7.6. Closing ceremony after races.

8. EQUIPMENT INSPECTION

8.1. Boats may be inspected at any time.

9. VENUE

9.1. Races: Clyde Cruising Club Dinghy Section, 6 Craigmaddie Rd, Milngavie, Glasgow G62 6EX

9.2. Saturday Dinner (BBQ): Clyde Cruising Club Dinghy Section, 6 Craigmaddie Rd, Milngavie, Glasgow G62 6EX

Sailors can arrive on site on Friday June 4th to view the facilities, start preparing charter boats, or deliver their own boats.

10. COURSE

10.1. The courses to be sailed will be detailed in the Sailing Instructions.

11. PERSONAL FLOTATION DEVICES

11.1. [DP][NP] Rule 40.1 applies. Each competitor shall wear a personal flotation device at all times on the water, except briefly while changing or adjusting clothing or personal equipment.

12. PENALTY SYSTEM

12.1. RRS 44.1 is changed so that the Two-Turns Penalty is replaced with by the One-Turn Penalty.

13. SCORING

- 13.1. A boat starting later than 5 minutes after their starting signal shall be scored Did Not Start (DNS) by the race committee without a hearing. This changes RRS A5.
- 13.2. Boats failing to finish within 10 minutes after the first boat in their Class sails the course and finishes, shall be scored Did Not Finish by the race committee without a hearing. This changes RRS 35 and A5.
- 13.3. 3 races are required to be completed to constitute a series.
- 13.4. A boat's series score will be calculated as follows:
 - 13.4.1. When 4 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

14. DATA PROTECTION

- 14.1. By participating competitors automatically grant to the Organizing Authority, the Race Committee and the Protest Committee the right in perpetuity to publish the results and decisions with the competitor's name, sail number and country.
- 14.2. By participating competitors automatically grant to the Organizing Authority and their sponsors, the right in perpetuity to make use and show, from time to time at their discretion, any (motion) pictures and live, taped or filmed video and other reproductions of the athlete during the period of the competition without compensation.
- 14.3. By participating competitors accept to receive event information from the Organizing Authority.

15. RISK STATEMENT

- 15.1. RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

16. INSURANCE

- 16.1. Each participating boat shall be insured with valid third-party liability insurance.

- 16.2. Personal insurance such as accident and health is the sole responsibility of each competitor.

17. INVASIVE SPECIES

- 17.1. CCCDS are committed to the prevention of the spread of invasive species following the Environment Agency and RYA guidelines – ‘CHECK CLEAN DRY’
