Script for submission:

I am filing a report against the Police of Riverside County California, Palm Desert California, and Gilbert Arizona for their negligence in the M. Tiffany case. They have been ignoring our pleas to investigate the abuse of M. Tiffany further and to get her a rape analysis kit for the suspected sexual abuse she is facing. They have been lying to us on social media and released news to NBC before the case was completed. They claimed that M. had an upset stomach and wasn't eating but M. had told Angelica that she was hungry and asked for food, and her father said no you can't eat. They also have been hanging up on callers, ignoring emails, and invalidating our claims of abuse. Angelica Mendez reported the abuse at a Palm Desert Costco and the police have now been gangstalking and threatening her for doing so. We know that Joel Tiffany worked as a 911 operator for AZ police and that he has connections with them so we find it very suspicious that they are taking more time to monitor and threaten Angelica instead of helping M. or investigating the abuse that she is facing.

8/24/21 When I called Riverside CPS they said that the family lives in Arizona and so AZ CPS is doing a cross investigation with Riverside. AZ CPS told me that they would look into it. I spoke with Brittni #3242

8/24/21 I was messaged by someone who said that the girl was riding in a car with the man and the rest of the family was in a different car. The plates were not registered. The person told me that the plates that were grabbed from a live video and were 7DQF638. Plates were looked up on carfax and belong to a 2013 Nissan Juke.

8/24/21

Information has been updated to include new #s and to reflect Riverside county info, not Riverside city. Riverside city Police contact Lashon Halley told me that this is a Palm Desert Police case.

8/24/21

Called Palm Desert police. They said they couldn't do anything besides add names to the open call list

Original posters video on YouTube was also deleted and I think her YouTube was deleted as well. We have heard word that the Police have been gangstalking her and waiting on her porch. @thatssobold on IG posted that they will be doing an interview with her ASAP.

WE FOUND THE MAN

he has been outed as Joel Tiffany, a dentist in Gilbert Arizona at Risas Dental and braces. His daughter in the video is M. Tiffany. Sources who worked with him at Risas dental say that he verbally abuses, controls, and is racist to his daughter. He is known to treat her terribly and refers to her as his "Black child" and never by her name.

8/24/21

SPOKE TO AZ CPS and filed a report Called Camille #3895

Follow up on report made with Brittni #3242 last night.

I mentioned that the dad, Joel Tiffany had kicked M. Tiffany in the Costco food court, was withholding food, known to verbally abuse her, and is suspected of sexually abusing her. She took down all information and said she will look into it and further the investigation.

8/25/21

Coworkers of Joel Tiffany come out about what they had seen in regards of abuse towards his daughter, M. Posts up on IG at @thatssobold

8/25/21

Was sent a screenshot from Becky Barlow Tiffany with a tagged Joel Tiffany asking for advice for a lawyer for "harassment and defamation" in the Riverside CA area.

8/25/21

Was sent this news article about the scandal in their county with the county assessor, Paul Peterson running a Black market illegal adoption agency that sells Marshallese children to MORMON people in specific

8/25/21

Posters on the case are being heavily censored. Reports of comments being hidden on IG, shadowbanning, tiktoks being deleted for "harassment and bullying", and accounts being deleted.

8/25/21

Classmates of their other daughter said they would lock that daughter in a closet and force her to play instruments. It is confirmed that she plays the harp.

8/25/21

Paris Milan, a YouTuber who has been discrediting the original story is suspicious to everyone who is actively investigating this case is concerned about who she is and why she's doing this.

8/25/21

Email script has been updated to reflect current information.

8/26/21

Gilbert police posted an update on IG stating "Gilbert Officers contacted the family and found the child to be safe and in good health. Through the investigation and subsequent interviews, it was found that the child had refused to eat the day of the video due to an upset stomach"

8/26/21

Original poster of the video showing abuse is back on Facebook. Case was reopened and closed in the same day.

8/27/21

Original poster of the videos Facebook account is deleted again. We have been using the hashtag #costcogirl to raise awareness. It's been said that it's important to keep it to one hashtag so that we can remain organized.

8/27/21

So far no response from any news outlets mentioned below.

8/27/21

Filed another report with Arizona CPS
Spoke to Diana #2751
Supervisor Meagan Tafoya has been put on the case.

8/28/21

Angelica was arrested without a warrant today in Palm Desert for "False crime to Spec POs" and "Give false info to POs" She was arrested for a misdemeanor and is being jailed without bail with a release date of 12/01/2021

Details of arrest:

The sheriffs asked Angelica to meet up for a local protection order, and they set her up. They ended up tackling her to the ground, giving her a Black eye and took her phone.

8/28/21

Angelica has been released from jail, in a video posted for @thatssobold she reveals that they had her sign a document that said she was lying and that they want her to say that she's lying in court. Her cousin was a witness.

Hello!

On 8/20/21, a woman made a Facebook post showing multiple videos of a young girl being abused by her adopted family at a Palm Desert, CA Costco foodcourt. The girl was not eating and didn't even have a drink, even though the rest of the family and children were all eating and drinking. As the woman then asked her some questions and the girl, revealed to be M. Tiffany told her, "they are raping me". The woman then called 911 and started recording while she waited for the police to arrive. When the Riverside County police arrived, they assessed the situation by talking to the family and not talking to M., not documenting any signs of abuse, and let them go. M. Tiffany said she was being raped, we worry that child sex trafficking is happening to her.

When Riverside county sheriff department did their investigation the other day and found no issue with the incident at Costco, I believe that they made a serious mistake. A mistake that could put this little girl in even more danger, and we are worried that she will be killed. Ultimately, the police of Riverside have done nothing, we need the child to be taken to the hospital and to be given a rape kit. Its also important that this child speaks with a person or organization that was created to help children who are suffering from sexual abuse. She needs help from someone she can trust, we urge the Police to bring someone from a child rape organization to her so that she can speak with someone who is educated enough to recognize the signs of child sexual abuse.

According to Angelica, this child said that she was being raped. They weren't feeding her. She looked very scared and traumatized. The family looked suspicious. Now on social media, the family's abuse is coming to light. Coworkers of her adopted father, Joel Tiffany have made claims that he said he gave M. an enema, and that M. cries because she is treated differently. He's also been known to verbally abuse M. and is known as a controlling man. A schoolmate of his other daughter, M2 had said that the Tiffany family locked M2 in a closet and forced her to play instruments. It is confirmed that M2 Tiffany plays the harp. The whole situation is not okay, we need you to look into this further as soon as possible. This poor child is in danger. M. Tiffany could be a victim of child sex trafficking and is a definite victim of child abuse. We need you to work with the proper parties to get this girl help. She is clearly being abused and you guys cannot prove that she isn't until you do a rape kit and take her away from this family so that she can tell the truth in a safe place.

We called Riverside CPS, they said that they are doing a cross investigation with Arizona CPS and the investigation was ongoing as of 8/24/21. So why did the Police speak with NBC news

on 8/23/21 and tell us that nothing is wrong? We need something to be done now. This is suspicious.

We are very worried about child sex trafficking. We are worried about the sexual abuse of M. by her family. We are also worried about the abuse of M2 and possibly other siblings.

Please get M. to safety, we are all very worried. It is clear that she isn't safe. It is clear that she is suffering from abuse by these people. Especially from her body language and facial expressions in the videos and given the details provided by the woman who reported this incident and the coworkers of Dr. Tiffany. She needs a rape kit done and the whole household needs a wellness check. This could be child sexual trafficking. We need to see some action now.

When Riverside police department did their investigation the other day and found no issue with the incident at Costco, I believe that they made a serious mistake. A mistake that could put this little girl in even more danger, and we are worried that she will be killed. Ultimately, the police of Riverside have done nothing, they keep hanging up on people, and ignoring emails and calls. Palm desert, CA police have just been adding names to a list and not helping at all.

This child said that she was being raped. They weren't feeding her. She looked very scared and traumatized. The family looked suspicious, and now lots of people are coming out about the abuse they saw her face while working with Joel Tiffany, and Becky Barlow Tiffany. The whole situation is not okay, we need you to look into this further as soon as possible. This poor child is in danger.

We called Riverside CPS, they said that they are doing a cross investigation with Arizona CPS and the investigation was ongoing so why did the Police speak with NBC news and tell us that nothing is wrong?

The police and CPS have been negligent in this case. The woman who posted the original video is being gangstalked by the police. People are banging on her doors and windows late at night, someone broke her window and she is being threatened. Why are the police so scared of this one woman? Why are they more worried about her than M. Tiffany, the girl who is being abused? We need help getting this story to come to light. There is something serious going on.
