

Privacy Policy

We take the privacy of our users very seriously at GlobalArchive. Most importantly, we do not and never will sell anyone's information to a third party.

This Privacy Policy gives a few more details about how we collect, use, maintain and disclose information collected from you when you use our site.

Personal identification information

We will collect personal identification information from you in a variety of ways, including when you register on the site and share Campaigns, Projects or Syntheses with other users. When registering users are asked for their full name, username, email address, affiliation(s), short biography and to provide external links to personal, institutional or other sites (e.g. Google Scholar, ResearchGate).

We will collect personal identification information from you only if you voluntarily submit such information to us by registering as a user. You can always refuse to supply the information.

Google and cookies

This website uses [Google Analytics](#), a web analytics service provided by Google, Inc. ('Google'). Google Analytics uses 'cookies', which are text files placed on your computer, to help the website analyse how users use the site. The information generated by the cookie about your use of the website (including your IP address) will be transmitted to and stored by Google on servers. Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage.

Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google's behalf. Google will not associate your IP address with any other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser, however, please note that if you do this you may not be able to use the full functionality of this website. By using this website, you consent to the processing of data about you by Google in the manner and for the purposes set out above.

How we use collected information

We will use your personal information for the following purposes:

Publically available

If you are the custodian of a Project, your username/email will be publicly available on the site, via the Explore page.

For logged in users

Additionally, if a GlobalArchive user is logged in, they can also see the email address, affiliation(s), short biography and external links provided by each user. In addition, logged in users will be able to see who is the custodian (or creator) of each Project or Synthesis. For Projects or Synthesis that were created by a user or shared with a user, that user will also be able to see the usernames of each user that the Project or Synthesis is shared with.

To send periodic emails

We may use the email address to send you information and updates about the site. It may also be used to respond to your inquiries, questions, and/or other requests. To be completely clear about this — you'll only get these from us, we'll never pass them on to "partners" or anything like that.

How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our site.

All communication between the site and you happens over an SSL secured channel and is encrypted and protected with digital signatures.

Sharing your personal information

We do not sell, trade, or rent your personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users in academic publications or conference presentations.

Third party websites

Any other sites that we link to will have their own privacy policies, which might differ from ours.

We have the right to update this privacy policy at any time. If we do, we will revise the updated date at the bottom of this page and email all users.
