- ★ Potential updates to the application calendar will be shared at https://international.ihu.edu.tr/ and Instagram account (www.instagram.com/ihu.international/). It is highly recommended that our students follow our announcements regularly.
- ★ Applicants for study mobility will be candidates for the Spring semester of 2024-2025 academic year.
- ★ In order to avoid delays after the announcement of results, the coordinator and students should carefully follow the application deadlines of the host institution.

B-WHAT ARE THE APPLICATION CRITERIA?

- 1. Being an active student in IHU.
- 2. A student can benefit from the Erasmus+ KA-171 International Credit Mobility Program for a maximum of 1 semester. Students are not allowed to extend their mobility as part of the KA-171 project rules.
- 3. Academic GPA of at least 2.50/4.00 for undergraduate students, and at least 3.00/4.00 for graduate students. Your transcript can be issued through e-devlet. Please make sure that your transcript is issued with dates after the start of application, i.e. 2 May 2024. **Transcripts without a valid date of issue or issued before 2 May 2024** will not be accepted and the application will be considered invalid.
- 4. A minimum score of 70 from the IHU English Proficiency Exam must be obtained. Equivalent exam results such as TOEFL (84/120), YDS (70/100), YÖKDİL (70/100), e-YDS (70/100), e-YÖKDİL (70/100) will also be accepted. The relevant exam results are **valid for two years** from the date of receipt. Students who want to apply with the previous IHU English Proficiency Exam will have to mark this option during the application phase on TURNA PORTAL.

Only one exam result will be taken into account. For instance, if you upload any

English exam result to the system or mark for the consideration of your previous IHU score, you **cannot** take the upcoming IHU English Proficiency Exam.

- 5. The following students **cannot apply**:
 - Students who are in Language Preparatory year
 - Students who are in their first semester of undergraduate or graduate program in Ibn Haldun University (IHU) and has no GPA during the application period from the courses registered in IHU
 - Students who came with a transfer from another institution and are in the first semester of their registration in IHU (i.e. a transfer student who has not yet received a GPA from courses taken in IHU during the application period)
 - PhD students who have not taken the doctoral qualification exam, and are in the last period of taking the exam (check the <u>Regulation on Graduate Studies</u>)
 - PhD students who are in the last period of their thesis proposal defense
 - PhD students who are in the last period of the maximum duration of the program
- 6. Masters or PhD students who are currently in 4th semester of their program and have not yet taken a seminar course and have not completed the program course load, must submit a permission petition from their thesis and/or academic advisor and the Institute Directorate within the application period.
- 7. Students who made a transfer from another program within IHU, can apply with their current GPA.

C- WHERE DO I APPLY?

Applications must be made through TURNA PORTAL https://turnaportal.ua.gov.tr

D- WHAT DOCUMENTS/FORMS ARE NEEDED FOR SUBMISSION?

At the time of application, the following documents must be uploaded:

- Transcript of Records (Mandatory)
- Scanned version of Turkish ID or residence permit (Mandatory)
- TOEFL/YDS/YÖKDİL/e-YDS/e-YÖKDİL Exam Result (it is mandatory only for those who will not take the IHU exam on 31 May 2024 or has not taken the previous IHU exams, and wants to submit other scores)
- Document proving disadvantagement mentioned in the list of criteria (if available)

• Petition of permission for 4th semester graduate students (if available)

Any application with wrong documents or misleading statements will be deemed invalid.

E- HOW IS THE EVALUATION MADE?

Student selections are made according to the selection criteria specified in the Erasmus+Implementation Handbook. The evaluation criteria and weighted scores to be used in evaluating the mobility applications are given below:

ATTENTION: Only the departments specified in the list can apply for this call of KA-171 Study Mobility (i.e. International Credit Mobility).

Other criteria mentioned in the table below are also taken into account in the evaluation. Based on these situations, reductions and increases are made on the total score:

Students with their first degree relatives or themselves residing in recent February 6 earthquake region of 17 cities or a district of Türkiye (The provinces of Adana, Adıyaman, Diyarbakır, Gaziantep, Hatay, Kahramanmaraş, Kilis, Malatya, Osmaniye and Şanlıurfa, Batman, Bingöl, Elazığ, Kayseri, Mardin, Niğde, Tunceli, and Gürün district of Sivas) 1st degree relatives mean: mother, father, child, spouse **	+10 points
Benefit from the KA171 program before (with or without grant)	-10 points
Participating in mobility in the country of citizenship	-10 points
Failure to participate in the mobility without giving a timely waiver notice despite being selected for the mobility	-10 points
Applying to two mobility types of KA171 at the same time (reduction is applied to the student's preferred mobility type)	-10 points
For students selected for mobility: Not participating in meetings/trainings organized by the higher education institution on mobility without an excuse (applicable if the student applies for Erasmus again)	-5 points
Not taking the language exam without an excuse (applicable if the student re-applies to Erasmus)	-5 points

- * Disability card or disability health report (Health report must not be older than 3 months and must be obtained from public hospitals' boards that are fully equipped with the authority to issue disability reports and deemed by the Ministry of Health) must be uploaded to the TURNA PORTAL before the end of application.
- ** This additional point will be applied to the preferred application of students who have more than one application. If the student resides in the earthquake region, he/she has to upload "Tarihçeli Yerleşim Yeri Belgesi" from e-devlet. If relative of the student is an earthquake victim, the student has to prove his/her relative's residency ("Tarihçeli Yerleşim Yeri Belgesi" of the student's relative from e-devlet) and also their degree of relationship ("Tam Aile Kayıt Örneği from e-devlet). As a second option, the student can upload a document from AFAD (wet-signed or retrieved from e-devlet) for proving the aid of his relative per his victimness. In both cases, documents must be uploaded to the TURNA PORTAL before the end of

- ★ Deduction of "-10 points" in case of previous benefit, does not apply to the activities carried out at the previous education level or activities other than higher education student/internship mobility. For example, if a student has achieved any mobility in the master educational level previously in IHU, graduated from masters level, registered again for PhD level to IHU and applied to Erasmus+ mobility in PhD level, deduction of -10 points is not carried out.
- ★ Considering all the criteria, if the total score calculated is equal, priority is given to the student with a high academic success grade. And if the academic success grade is equal as well, then the younger student is given priority.

F- ARE GRANTS PROVIDED?

Grants are given to students to ensure that some of their expenses are covered during their activity period abroad. The table of grant amount and travel grant to be given to students are given below:

G- ARE THERE OPPORTUNITIES AND ADDITIONAL GRANT SUPPORT FOR DISABLED AND DISADVANTAGED PARTICIPANTS?

Disadvantaged participants will be able to receive an additional grant of 250 € per month in addition to the grant they receive in student mobility whose activity period lasts between 2-12 months. In order for the grant in question to be awarded, the disadvantaged participant is defined as an individual with limited economic and social opportunities and who fits into the following sub-categories:

- Subject to Law No. 2828 (Those who have a protection, care or shelter decision by the Ministry of Family and Social Services pursuant to Law No. 2828)
- Students for whom protection, care or accommodation decision has been taken within the scope of Child Protection Law No. 5395

- Those who receive an orphan's pension
- Children of Martyrs / Veterans
- Persons who are granted financial support for themselves or their families (a document proving that the student received financial support from municipalities, public institutions and organizations such as ministries, Social Assistance and Solidarity Foundations, General Directorate of Foundations, Kızılay, AFAD are needed as proof during the Erasmus application)

H- WHAT ARE THE MATTERS TO BE CONSIDERED BY CANDIDATES CONSIDERING PARTICIPATION IN MOBILITY?

- 1- Double major students can only apply for the Erasmus Study Mobility with just one of their majors in the same application period.
- 2- The higher education institution cuts the grant in the following cases:
 - In case of failure, if the student who participates in the mobility cannot achieve 80% of the total ECTS taken in the relevant mobility for any reason that can cause absence or failure without a force majeure documented and accepted by the Commission, the entire grant is requested to be returned to the university.
 - In case a student does not complete the participant questionnaire, 20% of the total final grant is deducted, unless technical reasons were the cause. The minimum duration of activity is a minimum of 2 months for each student. Students who leave the program before this period is completed will not be able to receive a grant unless there is force majeure. Students who have to leave the program earlier than anticipated due to force majeure have to prove this with official documents.
 - In order for the grant to be paid in full, at least 2/3 of the total ECTS received in the relevant mobility must be successfully completed with a passing grade. Students who do not successfully complete at least 20 ECTS (or 2/3 of the total credits) out of the 30 ECTS must pay back the 80% received in the beginning of the mobility and are not eligible to receive the remaining 20% of the grant. Full academic recognition is given to successful credits in the program followed; failed credits are repeated at the host institution.
 - For students who have completed a minimum of 2 months of activity and return in less than the time specified in the invitation letter, the amount to be deducted is determined based on the number of activity days not performed.
 - If the documents proving participation in the mobility (certificate of participation or

the post-return transcript (ToR) that can replace it) are not submitted, the mobility

will be deemed invalid and the student will not be paid a grant; the previously paid

grant will be collected from the student.

3- Please carefully review the academic calendar of the institution you prefer and make sure

that it is compatible with the IHU academic calendar.

4- It is obligatory to take 30 ECTS courses in a semester. For this reason, you should check the web page of the relevant university (it can be under the headings of ECTS Course

Catalog, ECTS Info Pack, etc.) and make your choices by consulting your Erasmus

Department/Program Coordinator.

5- Double major students who will apply for mobility must have taken at least 25 ECTS in

their second major.

6- All the courses that students take abroad and are successful, will be recognized

academically at Ibn Haldun University.

7- Students who wish can waive financial support.

8- Non-grant students are also subject to a general evaluation together with other applicants

and go through the same process as grant students. Students who would like to participate in Erasmus+ Study Mobility by their own means, need to submit a petition of participating non-grant. The petition should be submitted after the announcement of results and **before**

the nomination deadline indicated in the calendar above.

9- In cases not specified in the announcement, the rules in the Erasmus+ Implementation

Handbook will apply.

10- Further details that will be encountered before, during and after the mobility for

the students who are eligible for Erasmus+ Study Mobility will be explained in the Erasmus+ Study Mobility Orientation where participation is compulsory (check the

calendar above).
