- Please provide a detailed, written explanation of the character[s], scenes, backgrounds, and items you would like created, or via Google form; and or clear visual reference(preferred).
- I, the artist, retain the right to decline or cancel a commission for any reason.
 - I, the artist, retain the right to post this work to Instagram, Tiktok, and any other site or social media. These will include the artwork, live streams, timelapses, and any reference images the client has provided.
- The client may not claim my artwork as their own, trace, or heavily reference my artwork.
- My signature may not be removed on any commissions for any reason. (If you require a transparent PNG or signatureless version, let me know in your order form/DM. Thanks!)
 - I, the artist, will not start a commission until I have received any filled forms/DMs and any reference photos(If applicable). Half payment upfront is required to protect the artist.
 - No refunds once the commission has been started. Sorry.):
- Finished work will be sent as a png over the platform the client reached out on, and lossless version will be sent over email- unless discussed otherwise.
 - If for any reason I am unable to finish a commission, I will offer the extent of the work I have done.
 - Final changes must be requested before the rendering phase.

Process Overview

- 1. The client will contact me through one of the links in the *contact me* section at the end. The Client will specify any time requirements, or file preference, or any needs now(see Google Form, or DM Order Outline).
 - 2. The Client will provide a filled Google form or a DM containing a detailed description of the character's physical appearance, and or photo reference (Preferred). The client will also specify any clothing, props, themes or settings that should be included.
 - 3. Once the commission is accepted, I will send a PayPal invoice to the email provided. Once the payment is confirmed, the Client will be added to the work queue.
- 4. Sketch phase: I will sketch out the idea provided by the client, once the sketch is understandable, it will be sent to the client for review- Once client approved, I will refine the sketch. It will be once again sent for review; or completion.
- 5. Colour phase (If Applicable): Once the refined sketch is approved, I will begin adding flats and gradients, I will send once again, for client approval. (This is the last chance for edits to be made to the piece)
- 6. Rendering phase (If Applicable): After the coloured work is approved, I will start adding lighting, highlights, shadows, and details. I will send another

invoice for the remaining 50%. All fees must be collected before the client receives their final file or artwork. The file will be sent to the client's preferred email.

Copyright/Usage

- I, the artist, *retain all rights* to the commissioned artwork- This means I am allowed to; Display the drawing on any social media platform, *cropped and* with a watermark. Unless specifically requested otherwise by the Client.
- The Client may use the commissioned artwork for *personal use only*, (Unless discussed otherwise) which may include; claiming the right of the character[s], but not the art itself, Sharing the art on their social media pages with *proper credit* to the artist.
