

This model of education and wealth looks at the variables that increase income, improve financial decision making and lead to wealth

The following characteristics are listed:

- Cognitive ability
- Non-cognitive traits (“grit”)
- Socio-economic status
- Education itself
- Education by-products
- Educated spouse
- Incentive to become financially savvy

Arrows show that these characteristics increase income and financial decision making, which both increase wealth.
