

Andrew Tudor, Dean @ WVC

17 years in Library/IT then became a Dean at the start of COVID.

14 years involvement with NWCCU as "the library guy" and lead writer on a panel. Preparing for Standard Updates - let your campus folks know that the library wants to be

involved in the updates. Last update was a bit of a blindside.

Process:

Colleges do not meet evaluators on year six teams. The teams receive a report then work through the commission to request additional materials as needed to try to determine if college is in compliance with evidence.

First read by the panel is the intense read, then they talk through differences & subtleties. Great or Not, doesn't matter at this point (it matters year seven).

Hard to evaluate a library without a visit... if something emerges in the writing, they might send someone on site to see if they are doing what they say they are doing. Libraries are all so very different. "What is a Library?"

Library Leadership structures have been changing. How does the commission view that? Focus is on sufficient "number and adequately qualified staff." If the library supports research and provides equitable access-- that is specialized knowledge. The commission isn't evaluating the structure of library leadership, yet. Helpful to bring up with on-site visits (year 7). Is this the kind of library that this place needs? Do you have enough staff? Be thorough, provide evidence, provide policies, procedures, etc., even though the standard is so vague it might be tempting to give a brief report. Focus on any part of how the institutional role is unique. Help the evaluator understand what is unique, and how time & resources are spent, and that you are doing what you say you do. Year 7 all read the year six report. Year six focuses on the college's technical reports & information from across the institution

Lynn D: [Lynn's Awesome Year 6 Standard 2H Link]

Previous evaluator, first time with new standards. Brief response to report. Not sure what to expect from the visit. Commit to incorporating more mention of the MLS qualifications in Library leaders in documentation.

Claire: combined year 6 & 7 visit -- visitor was not a librarian, questions weren't especially probing or difficult. Asked about outreach to staff, & asked about collection & online collection. Came out of the meeting feeling like they had some softballs, not much feedback, less rigorous feeling. Does individual leadership influence whether libraries are valued or not?

Dawn L: Prepped extensively, very little feedback from visit. Keep Linn-Benton in mind.

Tim: Nursing accreditations are more rigorous these days.

Gerie: Mid-cycle visit was very laid back.

Howard: Plug & play reports are the flipside to vague standards.

Andrew: Prescriptive doesn't work for continuous improvement.

When they come to evaluate the library, talk to them-- ask how they think libraries should address meeting the standard.

Ask ALO what sort of detail/appendices they need for year 6.

We could try to influence the structure of the next version, but we will need to do it differently than our last failed attempt.

Leslie: Change is coming, what is my part? What is my elevator pitch? Not feeling good with this in combination with being dropped from IPEDs. How do we manage these changes?

Cle: Served as accreditation evaluator previously. ACRL leaves community & tech colleges out of conversations around accreditation standards. The frameworks for larger institutions do not fit what we do. Admin looks at libraries to make fiscal decisions. This is a big problem. We should be looking to ALA/ACRL for support specifically for Community & Technical Colleges nationally.

There may be an opportunity to provide feedback to the standard review... check out the website for a timeline. "Here is what is missing. Here is what we need to see." Need standards to help speak the truth. We do not have control over what is in the report/narrative.

Should we as a council come up with our own standard language or template (top five things that we all address)?

What are our peers in other states doing? Rather not reinvent the wheel.

- How will we use AI to teach, do our work, how will students use AI in the workforce?

- Accessibility & equity & Resource Access (electronic databases)
 - Carleigh could reach out to Orbis Cascade to potentially collaborate on doing the work of checking the accessibility of databases. CATO can also join efforts. There's a library accessibility non-profit group (Carleigh) that collects that info: https://www.libraryaccessibility.org/testing.
 - Work with Monica from SBCTC.
 - What do we NOT need to worry about?

- Building community in LLC this priority is built into the other listed priorities.
- Accreditation develop a set of common standards/templates for all of us to reference.
- Involve campus librarians in state level work.
- CLAMS or group to set up librarians' community around the state
- Remember our Forever Goal with Equity lens on all work...
- Let's make a plan for at least one solid deliverable (and up to three, depending on bandwidth, feasibility, etc.) to work on between now and the end of the 2024-25 academic year

Washington State Library Updates (15)

 WSL updates from Jude Guzzy, WSL's Cooperative Projects Manager Jude Guzzy - semi-new to WSL. :) She is happy to be back in WA.
 Projects

- 1. Statewide Gale Package renewed for 24/25 with one more option to renew 25/26. Going out for bid late 25. What is the statewide database? How have things changed? Will be sending out a survey to find out what has changed/how the needs have changed. Data for WLA/presentation followed by focus groups. What is a statewide cooperative project? How is AI impacting this world?
- 2. OCLC statewide package. In negotiation right now for a new package (25 year old agreement).
- Washington Digital Library Consortium-- coordinates meetings, adding copies into their collection. Pooled funds into shared eBooks. Going to do strategic planning for that consortium.
- Palace Projects Lyrasis platform for audio/ebooks which allows other vendor platforms to be shared. (mostly focused on public libraries) https://washstatelib.libguides.com/Palace Project

Support from Carleigh Hill and Michael Brown (30) [slides]

- OpenAthens introduction
 - What is it? Carleigh's overview and suggestion: Switch from OCLC (does not want to negotiate, has security issues) to Open Athens (Ebsco), state level to create a better experience/coordinate with Okta, can be a single instance for the state with customized groups (Seattle colleges have to pay for 4 OCLCs, for example). Can be managed by WACTCLC. 30% discount from hosted EZ proxy. Benefits: long-term cost savings plus increased security (SAML handshake) Challenges
 - IT buy-in
 - Cost-sharing model
 - ?Pearl-Clover Park experience, why they switched
 - Currently using shared logins for off-campus access to databases, IT Director said either option could work, OA price includes analytics, OA UI more friendly to someone without a systems background, better relationship with EBSCO than with OCLC.
 - SBCTC welcomes an ask for migration cost coverage (Michael Brown)

 - To fit in to SBCTC budgeting deadlines -- get ask in by January
 - Probably would take 2 years to migrate by cohorts. No loss of functionality during transition.
