CATCHPENNY TOWNHOUSE STANDARDS DOCUMENT

Requirements

- Any exterior changes to a townhouse must adhere to the standards listed below.
- Any current exterior item not in compliance with these standards is "grandfathered in." But, all replacements/updates must adhere to these new standards.
- Homeowner may select own supplier (i.e. the suppliers mentioned below are not required).
- Material substitutions are not permitted.
- A completed A & L Form must be submitted to the Board for each proposed project.
- Board must approve A&L Form before homeowner can start on work. Please include pictures and/or links to websites that show materials and/or colors where appropriate. A complete form that meets all standards can be approved quickly. Approval may take a week so plan accordingly.

DOORS:

Storm Doors

- Full size glass, matching as close as possible to the color of the house (Lime White)
- If a full glass is too hard for someone to handle, there are doors that 'look' full, but are actually 3 pieces. (2 glass and 1 screen).

French Doors

- Matching as close as possible to the color of the house.
- Full glass doors

Garage Doors

• Steel Band, Board Panel Garage Door. Wood grain Texture. (Specific manufacturer or examples are welcome.)

Front Door

- Six raised panel
- No windows in the door
- Any new door must be same size as existing door

- Color must match the shutter color
- Door entrance side window plain glass.
- capping and trim, Sherwin Williams Lime White (if aluminum, as close as possible to this color)

Shutters

- Your shutters or door should not I be the same color as your next door neighbor's
- Louvered
- Color scheme to match

Windows

- Double hung, plain glass, without grill. Matching as close as possible to the color of the house.
- Window treatments must have a white/cream outward exposure.

Siding

Vinyl – Vipco - Country Beige

Roof - NOTE: Permit required by Middletown Township

- GAF Timberline HD Shingles Mission Brown (Even numbers)
- GAF Timberline HD Weatherwood (Odd numbers)

Light Fixtures

Black – keeping close to the style originally used

Walkways:

- Materials must be specified on A&L form
- Supporting material (i.e. pictures/drawings) are required for changes to existing walkway

Trim, Gutters and Downspouts

Match current color of siding, as noted above.

Deck and Privacy Barriers

- Any stain (i.e. no paint). If currently painted, color should be submitted with A & L form.
- Can also use a composite material like Trex. (sample must be provided with A & L form)
- Rails must be stained same color as deck.
- No enclosures permitted

Garden Walls or raised flower beds

• Currently railroad ties, however, more permanent replacement materials will be considered, similar to Abel Place, once A and L request has been submitted. (stone, EP Henry, etc)

Awning - not required

- Retractable
- Sunbrella material, beige/brown/neutral in color with limited stripes
