Introduction. These instructions give you basic guidelines for preparing a full-text article for the Brawijaya Journal of Urology.

Case. The manuscript should be written in English using A4 single-sided papers, single line space. We recommend the length of the paper fall short of 4 pages and not exceed 10 pages for optimum reading and understanding. To start writing the manuscript, follow the pre-set font type, size, and face given in this template, which uses Times New Roman of different sizes. Please complete all the required aspects including this abstract section and the e-mail and telephone/fax of the author to whom correspondence should be addressed.

Conclusion. The abstract contains 150-300 words. Please do not delete the bold text written for every part of the abstract, and please do not use any abbreviations and compound numbers in the abstract.

Keywords: provide 3-5 appropriate keywords suitable for your manuscript

Introduction

Introduction of the manuscript should be written in a good and grammatically checked English. State the objectives of the work and provide an adequate background, avoiding a detailed literature survey or a summary of the results. References must be cited by numbering [1-3], and they could be presented using reference manager [4], in which Mendeley is the recommended one [5-8]. Remember, mention the full form of abbreviations when they appear for the first time in the text.

Case Report

All papers, including the cover letter, must be submitted to the journal's website in a Microsoft Word format. Remember to use an A4 page size of 210 mm × 297 mm (8.27" × 11.69").

1) *Type sizes and typefaces:* To better maintain the focus and good readability, try to follow the type sizes below. We recommend following the table naming and format as shown below to represent any data in the table format.

2) *Format:* In formatting your page, set top, bottom, left, and right margins to 17.5 mm.

Left and right-justify your columns. Make sure to use correct hyphenation and spelling. All figures, tables, and equations must be included *in line* with the text. Do not use links to external files.

Discussion

Figures and Tables

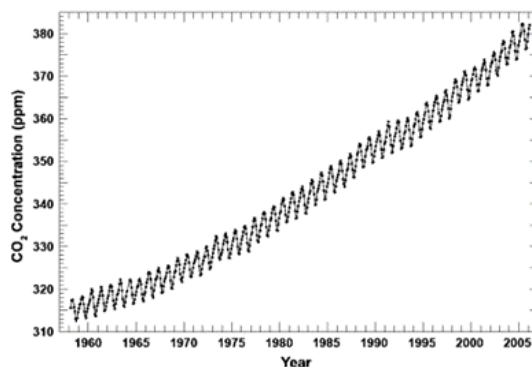


Figure 1. Title of figure

Figures and tables are positioned close to (preferably after) the first sentence or paragraph mentioning the related figure or table. Adjust tables and figures to fit the column length. Though it is not recommended, large figures and tables may span across both columns (Fig. 1), or completely be in a separate landscape page (Table 2).

Figure title should be below the figures; table title should be above the tables. Try to use words rather than symbols in the figure axis. Do not label axes only with units.

The findings are presented in this section. The actual results and discussion, are supported by schemes, figures, graphs, tables, reactions, and

equations. These items should be numbered in order of their appearance in the text of each category. Include titles, captions, and legends if possible to make them self-explanatory.

Use supporting software to make a good resolution of schemes and figures. In addition, the equation should be written using an equation editor.

Abbreviations and Acronyms

Define abbreviations and acronyms the first time they are used in the text, even after they have already been defined in the abstract. Abbreviations such as SI, MKS, CGS, ac, dc, and rms do not have to be defined. Do not use abbreviations in the title unless they are unavoidable.

Equations

Number equations consecutively with equation numbers in parentheses flush with the right margin, as in (1). Punctuate equations with commas or periods when they are part of a sentence, as in the previous sentence.

$$\frac{(X+Y)}{\text{Variables}} = Z \quad (1)$$

Be sure that the symbols in your equation have been defined before the equation appears or immediately following. Refer to “(1),” not “Equation 1,” nor “Equation (1),” except at the beginning of a sentence: “Equation (1) is”

Conclusions

The main conclusions of the study may be presented here as a short conclusion, which may stand alone or form a subsection of a Discussion or Results and Discussion section.

Acknowledgment

The acknowledgment should be brief and must be written about the original supporters of the work

and the reputed institutions. The information about the funding contract is strongly recommended including the contract number.

You may define any conflict of interest here.

(All cited references must be listed in this section, in order with Arabic numbering. We highly recommend that the submitted manuscript have a minimum of 5-10 journal articles. No maximum number of references)

- [2] Format for **books**: Author(s). Title. Edition. City of publication: Publisher; Year.
- [3] Format for **chapter in book**: Author(s). Title of chapter. In: Editor(s), editors. Title of the book. Edition. City of publication: Publisher; Year. Page range.
- [4] Format for unpublished research results such as **skripsi/thesis/dissertation**: Author. Title of skripsi/thesis/dissertation. Name of department/faculty, Name of university/Institution, Country; Year.
