### **Public Service Funding:**

Public Service Summer Funding Application is now available! APPLY NOW! You do not have to wait until you have secured a qualifying position to submit your funding application! This funding is available to both 1Ls and 2Ls, so everyone should apply if they think they might need the summer funding. You can always turn the funding down at a later date if you find a paid position (although, you should not rescind a job acceptance, so be sure before accepting an offer for an unpaid summer position).
