2024–2025 End-of-Grade (EOG)/End-of-Course (EOC) Testing Plan

Purpose of the Program

The purpose of the End-of-Grade (EOG) and End-of-Course (EOC) assessments is to ensure that all students have an equitable opportunity to demonstrate their academic knowledge and proficiency in alignment with state standards. These assessments are essential for evaluating student achievement, informing instruction, and contributing to school accountability metrics.

Testing Dates

Testing will occur during the final instructional days of the school year, beginning on Friday, May 16, 2025, and concluding on Friday, May 30, 2025. Specific dates and subjects include:

- Monday, May 12 – Thursday, May 15: Administrator training and test preparation
- Friday, May 16: First day of EOGs – 5th and 8th Grade Science
- Monday, May 19: 3rd and 4th Grade Reading (Both Campuses)
- Tuesday, May 20: 3rd and 4th Grade Math (Both Campuses)
- Wednesday, May 21: 5th–8th Grade Reading; Notification of 3rd–4th grade results
- Thursday, May 22: 5th–8th Grade Math and Math I EOC; 3rd–4th Grade Math Remediation
- Friday, May 23: Make-ups and 3rd–4th Grade Math Retest; Notification of 5th–8th grade results
- Monday, May 26: No School – Memorial Day

- Tuesday, May 27: Make-ups and 5th–8th Grade Remediation
- Wednesday, May 28: Make-ups and 5th–8th Grade Math Retest
- Thursday, May 29: Graduation; Make-ups, 5th–8th Grade Reading Retest, RtA Reading Retake for 3rd Grade
- Friday, May 30: Last Day of School

Remediation and Re-administration

- Students scoring Not Proficient on Reading or Math EOGs will be offered one opportunity to retest during the final days of school.
- Parent Permission Required: Notification sent via email or a printed letter; students may only retest with parental permission.
- Grouping: Students will be grouped appropriately for retesting.
- Instructional Time for Remediation:
 - May 22: 3rd–4th Remediation
 - May 27: 5th–8th Remediation
- Retest Sessions:
 - May 23: 3rd–4th Retest
 - May 28: 5th–8th Retest
 - May 29: 5th–8th Reading Retest; RtA Reading Retake (3rd Grade)

Testing Length and Timing

- Standard testing sessions vary by subject and grade but will follow the state guidelines (typically 3 hours with up to 4 hours allowed for students needing additional time).
- Remediation blocks will typically be 1.5 to 2 hours based on grade level and student needs.
- Each retest session will be scheduled for a full morning or afternoon to ensure adequate testing time.

Security of Test Materials

- All test materials will be stored in a locked, secure location accessible only to authorized personnel.
- Test administrators and proctors will complete state-mandated training on test security and administration protocols.
- Materials will be distributed and collected under strict inventory control.
- Breaches of security will be reported immediately to the Testing Coordinator and the Office of Accountability and Testing.

Testing Plan and Procedures

1. Preparation:
 - All administrators and proctors trained (May 12–15).
 - Testing rooms will be pre-approved for accommodations and proper spacing.

- Test tickets and materials checked for accuracy and readiness.

2. During Testing:

- Proctors in every session.
- Students grouped according to testing needs and accommodations (per IEP/504).
- Make-up testing days will allow for missed exams due to illness or emergencies.

3. After Testing:

- Student scores received and parents notified promptly.
- Opt-in retesting process initiated for students who were Not Proficient.
- Scores from re-administrations will count toward student proficiency but not toward growth calculations.
- Final scores submitted to the Annual Testing Program by July 7, 2025 for inclusion in the 2024-2025 accountability year.
