Bill Number and Title: HB 2984 - Oregon Conservation and Recreation Fund

Brief Description of Bill: HB 2984 appropriates \$1.5 million to ODFW for deposit in the Oregon Conservation and Recreation Fund (OCRF) for projects that "relate to water" and protect, maintain or enhance fish and wildlife resources. OCRF is overseen by an advisory committee and serves as a grant fund for projects that further the Oregon Conservation Strategy. In 2022, the legislature appropriated \$5 million to OCRF as part of the drought resilience package; the OCRF has been effective in spending down those funds on meaningful projects and this bill will help maintain that momentum. ODFW would receive a one-time appropriation of \$1.5 million General Fund for the 2025-27 biennium, deposited into the Oregon Conservation and Recreation Fund. Approximately \$1.4 million would be distributed through a competitive grant program with an estimated \$99,100 for administrative costs, including project planning and management, requests for proposals, technical reviews, and grant administration. The measure declares an emergency and takes effect on passage.

Drought resilience is a goal in Oregon. Treating the landscape with restoration will provide multiple benefits to State

residents, including maintenance of water supply and storage, and minimization of flood and wildfire risk. Given the responsibility ODFW has, to ensure endemic species are not extirpated, the priority species and habitats have been identified in the Oregon Conservation Strategy. Many of these species are in trouble due to landscapes whose hydrological processes were degraded. Techniques to restore the composition and function of these areas have been proven effective. However, the extent of the need is so great that the State funding for such projects has not been adequate to meet the demand.
