TERMS AND CONDITIONS

Judging will take place between 24th December 2023 to 26th December 2023.

- 11. Short-listed stories in the competition will run in the paper between 26th December 2023 and 26th January 2024. The stories will also be published and collated at www.newcastleherald.com.au.
 - 12. An overall winner, a highly commended entrant and the people's choice winner will be announced on Saturday, 27th January 2024.
- 13. The judges' decision on winners is final, and no correspondence will be entered into.
- 14. The winner will receive a \$200 voucher at Hamilton's MacLean's Booksellers and one (1) guest pass to the 2024 Newcastle Writers Festival.
 - The highly commended entrant will receive a \$100 MacLean's voucher and one (1) ticket to the 2024 Newcastle Writers Festival Opening Night.
 - The people's choice winner will get a \$50 voucher to spend at the Beaumont Street bookshop and one (1) ticket to the 2024 Writers Festival Opening Night.
 - All three winners will also receive a \$100 voucher courtesy of Domayne @ Harvey Norman Kotara.
