

1. The Centene SIU Game Plan

- Discussed about how Sovereign and other behavioral health centers across California and Arizona were cheated by Health Net.
- Discussed about Robo-signing of denials and arbitrary rescinding of all claims

2. Health Net HMO Policy Misleads Insureds

- Discussed the lack of coverage and provider network
- Discussed the Point of Service Product and how it was misused by Health Net
- Discussed the Assurance of Discontinuance signed by Health Net, issued by the Attorney General of the State of New York.

3. Centene Alleges Patient Brokering and Referrals

- Discussed the allegations in the cross-complaint by Health Net and Sovereign's stand on each one of them.

4. Centene SIU Drives FBI Raid against Sovereign

- Discussed depositions of Christina Khouie and Lisa LeGare which indicate that Centene instigated the raid against Sovereign
- Discussed Ken Julians' personal relationship with DOJ and Monica(Lead FBI agent)
- Discussed the atrocities inflicted upon both Sovereign staff and patients during the raid

5. Centene Sued for Lack of Adequate Network Coverage

- Discussed two class action suits filed against Centene.
- The first one- against the PPO policies of Centene and the lack of Behavioral Healthcare Providers in its network.
- Discussed how underpaying/not paying BH/SUD centers is the reason why out-network providers are refusing to take patients with Health Net/Centene Policies

6. Centene Mauls over Parity Laws

- Discussed how Centene flouted the MHEAPA by targeting BH/SUD centers in an industry wide SIU dragnet

7. Wall of Shame

- The Wall of Shame is a list of health care providers and companies that are under investigation for fraud. This list is available on the website of the Department of Health & Human Services.

- Discussed various incidents in the Wall of Shame where Health Net had been fined or castigated by federal agencies.

8. Blame Game at AHIP Annual Convocation

- This article is about how Daniel Kreitman, the Certified Fraud Examiner Director of Centene's Special Investigation Unit publicly alleged Sovereign Health Group AHIP Annual Convocation.
- Sovereign and other healthcare providers are accused of inflated billing, falsification of insured data, over billing of lab facilities, third party payment of premiums and co-ownership of lab facilities and health centers, identical billing addresses of patients and health care centers.

9. Centene Grows by Duping Shareholders'

- This article focusses on how Centene was sued by shareholders like Louisiana Sheriffs' Pension & Relief Fund, Pension Fund of Illinois and Iron Workers Local 11 Pension Fund of Chicago for misrepresentation and concealing Health Net's existing Liabilities worth \$ 390 million.

10. Centene Expands ACA Leaving Policyholders Aggrieved

- This article is about how Centene continues to expand ACA sales growth, offering minimal healthcare benefits to health insurance (Obamacare) policyholders.
- Talks about how the ACA policyholders suffered inadequacy of network and in-network healthcare providers.

11. Centene Penalized \$4,500,000 for Denying Overtime Wages

- This article shows how Centene willfully violated Fair Labor Standard Act (FLSA).
- It focusses on how care coordinators, call-center employees and case managers sued Centene over denial of overtime wages.

12. Centene WellCare \$17.3 Billion Merger under DOJ Scrutiny

- American Hospital Association doubts the impact of Centene WellCare \$17.3 Billion Merger and feels that this will reduce competition in the Medicaid space.
- AHA urges Department of Justice to scrutinize the merger and its present and future impact on the Medicaid market.

13. Centene's Faulty Ambetter Plans.

- Discussed how the Ambetter plans of Centene are being sued in 15 states
- Discussed how the plans are misleading insureds about the doctors and facilities enlisted in-network.

14. Centene WellCare \$17.3 Billion Merger under DOJ Scrutiny

- American Hospital Association is against the \$17.3 Billion Merger & Acquisition of Centene with WellCare.
- AHA is apprehensive about the anti-competitive impacts of the merger.
- AHA calls for Department of Justice to scrutinize this M&A.

15. Prescription Drugs Denied: Centene Faces CMS Penalty

- The Centers for Medicare and Medicaid Services (CMS) imposes Civil Money Penalty on Centene Corporation.
- CMS penalizes Centene for violating Medicare Part D, its Benefit Administration Plans and appeal and grievances rights.

16. Senator Holds Centene Subsidiary Responsible for Infant's Brain Injury

- Senator Bob Casey meets Centene CEO Michael Neidorff, seeking explanation for the denial of critical medical support. Neidorff did not accept the allegations.
- Casey urges the Centers for Medicare and Medicaid Services to investigate the case.
