

SPECIAL MEETING (2026 BUDGET #1), TOWN OF DANNEMORA SEPTEMBER 9TH, 2025

A Special Meeting - 2026 Budget Meeting #1 - of the Town Board of the Town of Dannemora, County of Clinton, in the State of New York was held at the Town of Dannemora Municipal Building, Chazy Lake, Town of Dannemora, 4:00 pm on the 9TH day of September 2025.

- Supervisor Coryer called the budget meeting to order at 4:00 pm.
- Pledge to the Flag and roll call was conducted.
- Supervisor Coryer went over the various departments and their requests.
- Court – Asked for no raise for both the Judge and the Clerk but did put in for envelopes and the training for the Judge.
- Custodian/Grounds – Supervisor Coryer put in for protective equipment for ears, eyes and gloves.
- Code Enforcement – Shane Rolich is requesting a laptop with a docking station, \$1,000.00 for safety supplies and \$200.00 for office supplies also \$200.00 for online code books. He requested that his pay be increased from \$12,000.00 a year to include the short-term rental inspections (which he already gets) and a \$1,000.00 cost of living raise, all equaling \$17,400.00 a year.
- Town Clerk – Rebecca Langlois is asking for stamped envelopes totaling \$1,800.40 (4 boxes) and the \$500.00 raise a year that everyone got 3 years ago but ended up not getting.
- Chazy Lake Dam Gatekeeper – Denis Fortin is requesting a high visual vest or rain jacket.
- Supervisor/Secretary – Supervisor Coryer is requesting a new computer for the Supervisor's office and a new printer for the Secretary, both are slowing dying and need to be upgraded.
- Highway Department – Mark Siskavich did not turn in his budget request.
- Supervisor Coryer went over the various funds and the numbers, explaining that the major changes were the insurance premiums, she noticed that the General Fund has been paying for most of it and should have been divided better throughout the other funds. The Lyon Mountain sewer and water rents may be decreasing next year. The Dannemora water rents may be decreasing but the sewer will stay the same. Ledgers Water district added two more units so that water rent may go down. The Town will be losing its income from the iron ore sales, which may increase property taxes. The Board discussed the raises but would like to go into Executive Session to discuss it more.
