Dear Parents/Guardians and Students:

To use any technology for our educational program, students must have this signed agreement on file. Please read this together, and acknowledge through the Genesis Parent Portal.



Statement of Purpose for Parents

The South Brunswick School District (SBSD) believes that all students should have access to technology tools, resources, and services when they act in a responsible, efficient, courteous, and legal manner. Internet access and other online services, available to students and teachers, offer a multitude of global resources. Our goal in providing these services is to enhance the educational development of our students.

We educate students about appropriate online behavior in an ongoing manner including awareness and response to cyberbullying, and as appropriate, interacting with others on social media and networking sites.

In addition, while on the school network, we take steps to:

- Block access by students to inappropriate matter on the Internet and the World Wide Web.
- Monitor the safety and security of students when using electronic communications.
- Prevent unauthorized access, including “hacking,” and other unlawful activities by students online.
- Prevent unauthorized disclosure, use, and dissemination of students’ personal information.
- Measure restricting students' access to materials harmful to them.
- Filter and monitor Internet use on school networks.

Definitions

This Technology Use Agreement references tech tools and electronic communication, used in South Brunswick grades PK-1 educational program.

- ✓ **Tech Tools.** This refers to all digital tools and equipment including, but not limited to computers, laptops, Chromebooks, iPads, SmartBoards, digital visualizers, cameras, videoconferencing, etc.
- ✓ **Electronic Communication.** This means a communication transmitted by means of an electronic device including, but not limited to a telephone, cell phone, computer, laptop, Chromebook, iPad, tablet, iPod, audio/video player, camera, videoconferencing, etc.

Student Agreement

Terms of Agreement for Pre K, K, and 1st Grade Students

Using tech tools correctly and responsibly is very important for teaching and learning. I promise to follow these rules, when using district technology:

1. I promise to use all district tech tools carefully and not do anything that might break or hurt the tech tools provided by my school.
2. I promise never to use the tech tools to hurt, frighten or bully others.
3. I promise to only work on the apps and websites that my teacher tells me to use for school work.
4. I promise to ask for help if I don't know what to do.
5. I promise to tell a trusted adult if I read or see something that is not appropriate.
6. I promise to follow the rules for proper behavior, and to be safe and caring online.
7. I promise to follow the school rules when videoconferencing with my teacher and classmates.
8. I promise to never talk with strangers online.
9. I promise to tell a trusted adult if a stranger tries to talk with me online.
10. I promise to never, ever share private information, passwords or pictures online about me, my family, my pets, my home, the school I go to, my friends or anyone else.
11. I promise to never take a picture, or record sound or video, unless my teacher says I can.
12. I understand that if I break any of my promises, I might not be able to use the tech tools.
