

Explanation of ERISA

The federal Employee Retirement Income Security Act (ERISA) was passed in 1974 to provide security and uniformity across the nation for pension, health, and other benefits provided by employers. ERISA declares that the federal government has priority in governing such plans, and states cannot establish laws or programs that regulate or otherwise impact such plans.
