6. Unfinished Business:

We have newly designed medals. Jerry Mason and Harry Foster believe they/we are ready for the upcoming tournament. There are still shifts open on Kitchen, Ticket Sales and Snack Shack.

b) Ladies/Men's Open Groups-not happy that they are no longer getting balls for their group. They may go play elsewhere. Rhonda Shubert is starting an open group @ 2.5-3.0 level. Open groups must accept any level player.

c) Rec Tennis-Guidelines state there will be 3 levels of play which are 1.5-2.0, 2.5-3.0 and 3.5-4.0. Each level must have a Coordinator. Rec players must belong to the SSV T club, pay dues and are expected to help with maintenance and upkeep of courts, help work tournaments and be involved in all social events. The Tennis Club will

provide tennis balls for each court of Rec Tennis players once per week. If an EVSTL player would like to switch to Rec Tennis, they must report it to their Captain by March 14. Please refer to the remainder of the guidelines on the ssvtennisclub.org website via Club Info and Recreational Tennis.
