*****SPECIAL NOTE TO PARENTS OF KINDERGARTENERS:** The First Catholic Slavic Ladies Association of Howells will offer \$200 off tuition for all Kindergarten students this year. Please subtract the \$200 when you make your tuition payment.

St John and SS Peter & Paul Churches pay a subsidy for each parishioner's child that attends HCCS. This is why parishioner tuition is lower than that of the non-parishioners.

Instead of writing checks, you have the option of authorizing an automatic monthly payment from your bank account to HCCS for your tuition obligation. If you wish to make automatic payments, please contact your bank to get this process started.

By August 15th, please select a payment option and return the lower portion of this form to HCCS along with your first payment; or complete an automatic payment form as mentioned above. Please make every effort to pay your tuition by the due dates you choose. **Again, unless you fill out an automatic payment form, your first tuition payment is due on August 15th.**

Tuition Payment Options – Choose One

_____ LUMP SUM PAYMENT: I/We elect to pay 100% in full by August 15, 2025.

_____ SEMI-ANNUAL PAYMENTS: I/We elect to pay 50% by August 15, 2025, and 50% by January 15, 2026.

_____ QUARTERLY PAYMENTS: I/We elect to pay 25% by each of the following dates:
August 15, 2025 November 15, 2025 January 15, 2026 March 15, 2026

_____ MONTHLY PAYMENTS: I/We elect to pay 10% by the 20th of each month from August 2025 through May 2026.

SPECIAL ARRANGEMENTS: If it is financially necessary to make special arrangements for the payment of tuition, you may request this option by contacting Father Walter or Karen Baumert before August 15th, 2025. Father Walter can approve reduced tuition amounts or a longer schedule of payments, but you must commit to an amount or schedule reflecting genuine ability to pay. These payments will then be due according to the same schedule outlined above under "Monthly Payments".
