Fee Structure

The Fee Structure tables below layout the costs for sessions. All individual 1 on 1 sessions have a flat rate fee. When booking multiple individual sessions a discount is applied to the hourly rate as outlined in each of the Fee Structure Tables.

Group sessions can consist of 2 or 5 individuals that are in the same course/studying the same material (applies to all students and adult learners; Teacher support/training can have up to 5 persons). As with the individual sessions the Group session has a flat rate fee, and a discounted hourly rate fee for all multiple group sessions as laid out in each of the Fee Structure Tables.

The first session that is booked will be a consultation session, and there will be no cost incurred for the consultation session. During this session an introduction, review of the contract, and the needs of the client will be addressed.

All the multiple hour sessions are required to be used within a 30 day period.

Schedule of Sessions

Cancellation of Sessions by the Client

The Client may cancel sessions by giving at least 24 hours prior notice to EduTech Support & Resources in which case no session fees will be incurred. Sessions not attended by the Client without giving 24 hours prior notice to EduTech Support & Resources shall be charged at the full rate.

Cancellation of Sessions by the Client

EduTech Support & Resources may cancel lessons by giving 24 hours prior notice to the Client in which case no fees shall be incurred. Where a session was pre-paid, EduTech Support & Resources shall reschedule the session to a time agreeable by both parties, failing which the Client shall be refunded the fee for the session.

Late Arrivals

Fees are calculated according to the times stipulated in the Fee Structure Tables and no adjustments shall be made for time lost because of late arrival by the Client.

Any lost time because of the late arrival of EduTech Support & Resources shall be compensated for by extending a lesson by mutual agreement and by such amount of time that was lost.

Obligations of EduTech Support & Resources

- EduTech Support & Resources agrees to do all preparation prior to each session and to structure the sessions in such a way as to optimize time to the benefit of the Client.
- EduTech Support & Resources shall keep confidential all information of the Client

EduTech Support & Resources makes no promises or warranties with regards to a Client's performance as a result of any support provided.


Minors
