## Your Full Title of Your Paper

This is where you actually write the text of your paper. In it, you should summarize and analyze (meaning, *interpret and make connections*, don't just "tell") what is known about your topic. This means you probably should start with an introduction that has a claim or organizational statement which guides the rest of the paper. You will also want to address how you chose to apply this information in Part II of your project and *why*. The concluding paragraph might be a good place for that, but use your best judgment. There should be some logical connection between what the scholarly research is saying about your topic and what you choose to do.

Also, this section of your paper should include a whole bunch of in-text citations for all those scholarly articles you are referencing. Maybe your paper is on unwarranted credulity amongst college students, so you want to include that article on pseudo-profound nonsense we looked at in class (Pennycook, Cheyne, Barr, Koehler, & Fugelsang, 2015)? Or, perhaps you were inspired by Middlemist, Knowles, and Matter (1976) and decided to make urinal use the focus of your project? In any case, any paper or source referenced in an in-text citation needs an accompanying entry in the reference list at the end of the paper..

In case you forgot, this part of the paper should be two to three pages in length. If you are jointly working on your paper with a group, the paper should be longer and include more sources, obviously. Don't let social loafing get the best of you on your final project!

I would *highly recommend* making a copy of this document and using it as the basis for your paper, since all of the junky formatting that APA style requires (e.g., margin size, headers, spacing, separate pages for different sections, hanging indents on the references list) is already

done for you. If you are trying to be a cowboy and do this all on your own, it gets pretty painful in Google Docs. APA style was really designed with Microsoft Word capabilities in mind.
