Proposers are required to carry all appropriate insurances. Certificates of insurance must be on file with the Unit **before** any work begins.

Prices of proposals are to be effective and honored for a period of **Thirty (30) days** from the proposal opening.

Proposals may be withdrawn by the proposer in writing within three (3) days after the opening date. Thereafter, a proposer may not withdraw their proposal.

Any proposer submitting a proposal hereby certifies that no member of the Board of Education, agent, or employee of the Unit has pecuniary interest in the proposal and that the proposal is made in good faith without fraud, collusion, or connection of any kind with any other proposer for the same work.

All hazardous substances shall be labeled in accordance with Maine law. Every container shall bear a label indicating the name of the chemical and chemical abstract number (CAS#) of all hazardous substances in the container, and all other substances that are among the five most prominent substances in the container. Also, a material safety data sheet (MSDS) shall accompany every product.

The Unit reserves the right to reject any or all proposals in whole or in part, and to waive any formalities or technicalities therein, to call for re-proposals, to negotiate with any proposer, or to reject any proposal that is determined to be not responsible, should it be in the best interest of the Unit.

Proposals must be submitted in sealed envelopes. Each envelope must be clearly marked with the name of the proposal and the proposal date and the time of the opening. Vendor's name and address must be on the proposal sheets. Late proposals will not be accepted under any circumstances.
