Pastoral Care Levy

\$72 - this levy offsets a number of small charges that occur throughout the year and allows parents, as well as school administration, to streamline budgeting and save time organising payment. The levy covers the costs associated with Reflection Days, bus trips to the parish church for Masses throughout the year, and other events. All of these are **compulsory activities for students** at St Paul's College and the cost has been kept to a minimum.

Subject Levy

Certain courses at St Paul's College incur a substantial cost in resources (i.e. timber, food, paints, metal, material, etc.). To be equitable to all students, those who undertake study in the following courses are asked to cover the cost of these resources by paying a subject levy.
