### Writing guide

- The editor accepts the manuscript for publication in the form of research results
- · Articles are written in English
- · Article Writing Format:
- Research results consist of: Title, author's name, abstract, introduction, methodology consisting of a) materials and tools and b) methods, results and discussion, conclusions, acknowledgments (if necessary), and bibliography
- Reviewer results consist of: Title, author's name, abstract, introduction, sub-chapter topic, conclusion, acknowledgments (if necessary), and bibliography

The first author is responsible for the content of the article, correspondence regarding the article should be addressed to the first author.

- Submission of articles is accompanied by a statement/permission for publication from all authors whose names appear on the article.
- · Article Typing Requirements:
- Typed one and a half spaces, with a maximum of 10 pages, using the Microsoft Word program, Times New Roman typeface, 12-point font, 'Regular' (specifically for the

title: 14-point font, Bold). Chemical structural formulas can be created with Chemwin or Chemdraw. Photos and images can be used in jpg/jpeg format and for graphics you can use excel.

Manuscripts should be sent in file form (softcopy) or email and one copy printed on one side on A-4 size white paper (210 x 297 mm), with an margin/ edge distance of 2.5 cm from all sides. Image files should be separately from script files and sent in .doc (Word 97-2003 Document) format, not .docx (Word Document).

## Title page

- Titles are short and clear, in English using capital letters at the beginning of the word, except for conjunctions and prepositions
- Name of the author/authors (no title, first name written in lower case except the first letter while last name written in all capital letters) along with the full name of the author's institution. If the authors come from different agencies then use the signs 1), 2), 3) and so on after each author's name. The author of all correspondence addresses is marked \*) and the agency address must be listed in full along with the e-mail address (if any) in font size 11.
- The institutions of the first, second and subsequent authors are written in full **Abstractor Summary**
- Abstracts are written in one paragraph with a maximum of 200 words and written with one space.
- Abstract contains highlights of research results followed by quantitative data from research results that stand out and are related to the title and need to be disclosed, so that readers can immediately find out the research findings
- ❖ Include keywords with a maximum of 5 words

### Introduction

The introduction include background and literature citations which conclude by stating the research objectives.

#### Method

- The specifications and sources of the materials used are clear
- The specifications for the tools used are clear, while simple tools such as glassware do not need to be written down

The method used must be reproducible and if taken from other sources be accompanied by citations

#### **Results and Discussion**

- \* Table and Figure titles are numbered and capitalized, starting with a capital letter
- Tables and their descriptions must fit within on one page. The table title is written at the top of the table with an Arabic serial number in the center position
- ❖ Images, including graphics, are created separately from the manuscript, with a maximum 1 page and a minimum ¼ page. The image title is written at the bottom of the image with an Arabic numeral number.
- ❖ If there is a photo (black and white photo) it must be printed on white paper and accompanied by a description
- The discussion of research results should be accompanied by related literature support

#### Conclusion

Conclusions are drawn from the results and discussion, referencing the research objectives.

# **Acknowledgment (if necessary)**

You can write the name of the agency or individual who assisted in carrying out the research.

#### Reference

- ❖ The bibliography is arranged alphabetically by the last name of the first author.
- Using the citation standard application (Mendeley/Endnote) is a must with American Psychological Association (APA) 7 th edition.
- ❖ The author's name is preceded by the family name/last name followed by the first letter of the first name/first name, whether written in full for the first, second or subsequent authors.
- The title of an essay for a book is written with a capital letter at the beginning of each word, except for conjunctions and prepositions.

- Magazine/Journal/Bulletin Name: all author names are mentioned after it is written in the year of publication, article title, magazine/journal name and volume (italiced) last page number.
- ❖ Book: all author names are mentioned after it is written year published, article title, editor name, book title and volume (italicized), edition, publisher, city, page number.
- ❖ Libraries from the internet include the date at the time of quoting.

**Keywords:**word1, word2, word3. Maximum 5 keywords separated by commas. [Times New Roman font 12 single spacing]

#### 1. INTRODUCTION

The introduction includes the background to the issue or problem as well as the urgency and rationalization of research activities. Activity objectives and problem solving plans are presented in this section. A review of relevant literature and hypothesis development (if any) are included in this section. [Times New Roman, 12, Regular].

#### 2. METHOD

### **Subtitle1 (eg: Research Materials)**

The research method explains the activity design, scope or object, main materials and tools, place, data collection techniques, operational definitions of research variables, and analysis techniques. [Times New Roman, 12, Regular].

### **Subheadings 2 (eg: Extraction and Formulation)**

The research method explains the activity design, scope or object, main materials and tools, place, data collection techniques, operational definitions of research variables, and analysis techniques. [Times New Roman, 12, Regular].

## **Subheading 3 (eg: Activity Test)**

The research method explains the activity design, scope or object, main materials and tools, place, data collection techniques, operational definitions of research variables, and analysis techniques. [Times New Roman, 12, Regular].

### **Subheading 4 (eg: Data Analysis)**

The conclusion contains a brief summary of the research results and discussion, related to the hypothesis and answering the research objectives. Conclusions are written in paragraph form instead of numbering. [Times New Roman, 12, Regular].
