- Approval of Minutes
 - o Question to add a note that we will continue the conversation with Paula
 - o Deb made motion to approve, seconded
- Recognition of those whose tenure as board representatives are ending

 - Joyce shared sentiments of gratitude for each of these three Board Members
 - Asked Jade, Deb, and Michael to offer their thoughts about a consultant and views on the next steps for MIP. They each spoke and others in attendance acknowledged their contributions.
 - Discussion regarding the Consultation
 - o Joyce shared the 3 consultants we had been in touch with Stephen Gresham, Paula Kliger, and Visions.
 - o Linda Gelda suggested Kathy Pogue White
 - o Discussion regarding the consultant continued. Issues raised about what the consultant would focus on:
 - Would they address just DEI/Antiracism issues, or would they also be knowledgeable regarding issues of governance at analytic institutes?
 - Jade reminded us of the consultation with Michelle Kweder where governance was addressed.
 - Someone expressed hope that a consultant would mediate a conversation between the task force and the letter writers.
 - Many board members spoke to the urgency of finding a consultant and the need to address the tension and division on the board.
 - Joyce asked people to let her know if they were interested in helping to interview possible consultants.
 - Some people asked for more conversations with Paula.

- There was concern about how to choose the consultant.
- It was suggested that there would be a planning group that would interview the potential consultants.
- The Board asked to be able to vote on which consultant they would like to hire.
- Membership Committee and Treasurer:
