INTRODUCTION (Arial Narrow 12, bold)

The introduction consists of a research background, supporting theories from several references that form a clear theoretical foundation, problem formulation, and research purpose. The introduction is written in one chapter without subtitles. The entire explanation in the article is written in essay form, so there is no numeric format and/or alphabet that separates chapters/sections or to mark new chapters/sections. For this reason, if there is a



part of the article content that requires a numbering or bullet list, make it flow into paragraphs as follows: (1) one, (2) two, and (3) three.

METHODS (Arial Narrow 12, bold)

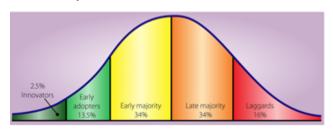

CONCLUSION (Arial Narrow 12, bold)

Conclusion content consists of answers to research questions and aims. The conclusion is presented in a paragraph, not by points, and not by statical words. The conclusion is completed with research results suggestion

REFERENCES (Arial Narrow 12, bold)

References are sorted by Alphabetical citation on the article as endnotes and are not separated between book sources, online, and others. Authors are required to use the Mendeley application in compiling bibliography. Source of referral between the last 10 years until today with the composition of primary references (journals) 80% and secondary sources of references (books) 20%.

Minimum references are 15 journal articles (80%), and 5 books (20%) with relevant subject on your article.

References are written using the APA 6th Edition citation system, font Arial Narrow 10, Space 1. See examples of technical requirements for writing the references below
