

# durumis Tartalompolitika

A durumis egy szolgáltatás az önálló kifejezésre és kommunikációra. Lehetőséget nyújt a felhasználóknak az információ elérésének növelésére, az egészséges viták ösztönzésére és másokkal való új módon való interakcióra. A tartalom cenzúrázása a durumison a szolgáltatás szellemiségének megsértésének tekintendő, amely a szólásszabadságon alapul.

Ezen értékek tiszteletben tartása érdekében a durumis bizonyos korlátozásokat ír elő a durumison közzétehető tartalmak típusaira. Ezeket a korlátozásokat jogi követelményeknek való megfelelés érdekében alkalmazzák, és az általános szolgáltatásminőség javítása érdekében.

Egy biztonságos közösség fenntartása létfontosságú, és kiemelten fontos olyan tartalom bejelentése, amely megszegi a durumis Közösségi Útmutatóját. Ha olyan bejegyzésbe botlott, amelynek úgy gondolja, hogy megsérti a közösségi irányelveket, használja a jelentési hivatkozást, amely általában megtalálható a blog navigációs menüjében. Ha nem találja a jelentési hivatkozást a blogon, itt jelentheti be a gyanús jogsértéseket.

## Közösségi Útmutató

A durumis Közösségi Útmutatója kulcsfontosságú szerepet játszik abban, hogy minden felhasználó biztonságosan létrehozassa a tartalmát ebben az online térben. Kérjük, tartsa be a következő irányelveket, mivel a szabályok idővel változhatnak. Kivételek előfordulhatnak művészeti, oktatási, dokumentumfilmes vagy tudományos szempontokat érintő esetekben, és intézkedéseket nem hoznak, ha a cselekvés hiányában jelentős közérdek fennáll.

## Felnőtt Tartalom

A durumis nem engedi a felnőtt tartalom, beleértve a kifejezetten meztelen vagy szexuális cselekedeteket tartalmazó képeket vagy videókat. A durumison közzétett

felnőtt tartalmakat szabályozó kritériumok a Dél-Korea 'Broadcasting Communications Review Board' és a 'Youth Protection Act' által meghatározott szabványokon alapulnak. Mivel a blogbejegyzések mindenki számára elérhetőek, a felnőtt tartalmak közzétételétől a kiskorúak védelme érdekében erősen eltanácsolják.

## Child Sexual Abuse and Exploitation

Content that deals with child exploitation and abuse is strictly prohibited. This includes all content related to child sexual abuse. If you come across content on durumis that involves child exploitation, you can report it using the abuse report link. For content found on other websites, please contact the relevant authorities in your country.

More broadly, durumis prohibits engaging in actions that put children at risk using durumis products. This includes but is not limited to:

- Child grooming (e.g., befriending a child online and then encouraging sexual contact or exchanging explicit content online or offline).
- Webcam phishing (e.g., accessing or pretending to access a child's private images and using them to threaten or coerce the child).
- Sexualizing minors (e.g., describing, encouraging, or inciting child sexual abuse).
- Child trafficking (e.g., advertising or proposing commercial child sexual exploitation).

On durumis, such content is deleted, and relevant measures are taken, such as reporting to the National Center for Missing and Exploited Children in South Korea or the police (112), restricting access to product features, or suspending accounts. If it is believed that a child is in danger or exposed to risks of abuse, exploitation, or human trafficking, please report it to the police immediately.

## Dangerous or Illegal Activities

Using durumis to engage in illegal activities or promote products, services, or information that cause serious and immediate harm to people or animals is strictly prohibited. While durumis allows for general information related to education, documentaries, science, or art, content that directly causes harm or encourages

illegal activities is restricted. durumis takes appropriate actions, such as removing content or reporting to relevant authorities, upon receiving reports of illegal activities.

## **Harassment, Violence, Threats**

Harassing, threatening, or coercing others, whether directly or by inducing others to engage in such behavior, is strictly prohibited. This includes maliciously targeting specific individuals, making threats of serious harm, engaging in unwanted sexualization, exposing private information that could be used for threats, and inciting or encouraging harassment. Online harassment is illegal in many regions and can have serious consequences offline as well. If threats or other dangerous situations are reported to durumis, appropriate actions will be taken, such as reporting to relevant authorities.

## **Expression of Hate**

Engaging in hate speech is not allowed. Hate speech includes content that incites or promotes violence against individuals or groups based on race, ethnicity, religion, disability, age, nationality, military service, sexual orientation, gender, or gender identity, or any other characteristics that can lead to discrimination or marginalization.

## **False Statements and Identity Misrepresentation**

Using someone else's identity or providing false information about oneself, particularly regarding ownership, intent, products, services, or business, is strictly prohibited. While parody, satire, and the use of pseudonyms are allowed, content that may mislead readers about the author's identity is not permitted.

## **Malware and Similar Malicious Content**

Transmitting malware or content that can harm or disrupt the operation of networks, servers, end-user devices, or other infrastructure is strictly prohibited. This includes hosting, inserting, or transmitting malware, viruses, destructive code, or other harmful or unwanted software. Engaging in activities such as attempting to transmit viruses, displaying pop-ups, attempting to install software without user consent, or using other malicious code to cause harm to users is also prohibited.

## Misleading Content

Distributing content that deceives or misleads users, causing confusion, is strictly prohibited. This includes content that contains misleading information about civic and democratic processes, harmful conspiracies, or health-related practices that may lead to severe physical or mental harm. While certain misleading content may be allowed in an educational, documentary, scientific, or artistic context, sufficient information must be provided to help people understand the context. In some cases, even with adequate explanation, certain misleading content may not be allowed on the durumis platform.

## Non-consensual Explicit Images (NCEI)

Saving or distributing private nudity, explicitly sexual, or non-consensual explicit images without the explicit consent of the individual is strictly prohibited. If someone has sent explicit images without your consent, you can report it to durumis [here](#).

## Personal and Confidential Information

Unauthorized storage or distribution of someone else's personal or confidential information is strictly prohibited. This includes sensitive information such as resident registration numbers, bank account numbers, credit card numbers, images of signatures, personal health documents, and other private information. durumis typically does not take corrective action for widely available information found on the internet or public records.

## Phishing

Using this product for phishing, including requesting or collecting sensitive information such as passwords, financial information, or resident registration numbers, without proper authorization is strictly prohibited.

## Regulated Goods and Services

Selling, advertising, or promoting regulated goods and services such as alcohol, gambling, pharmaceuticals, unapproved supplements, tobacco, explosives, weapons, or healthcare devices is strictly prohibited on durumis.

## Spam

Sending spam is strictly prohibited. This includes unwanted promotional or commercial content, automatically generated unwanted content, repetitive content, meaningless content, or content that appears to encourage bulk purchasing.

## Violent Organizations and Groups

The use of durumis by known non-state violent organizations and groups for any purpose is strictly prohibited. Content that encourages or promotes the activities of such organizations, including recruitment or coordination of online/offline activities, sharing harmful instructions, advocating ideologies of non-state violent organizations, inciting violence, or endorsing acts of violence by non-state violent organizations is not allowed. Content related to non-state violent organizations may be allowed in an educational, documentary, scientific, or artistic context, but sufficient information must be provided to help people understand the context.

## Unauthorized use of images of minors

Images of minors should not be stored or distributed without the explicit consent of the child's parents, guardians, or legal representatives. If someone has stored or distributed images of a minor without obtaining the necessary consent, please report it to durumis.

## Violent and bloody content

Storing or distributing content that handles real people or animals in a violent or cruel manner with shocking, explicit, or unnecessary intent is prohibited. This includes content with explicit depictions, such as videos shot in close proximity to physical harm or of mutilated bodies, and content with excessively vivid descriptions. While such content may be allowed in educational, documentary, scientific, or artistic contexts, it should provide sufficient information for people to understand the context. Extremely violent or shocking content cannot be posted on the durumis platform, regardless of the explanations provided. Lastly, do not encourage others to engage in specific violent acts.

## Copyright

durumis follows a policy of taking action in response to clear reports of copyright infringement. For detailed information on durumis' copyright procedures, refer to this

link. Additionally, do not provide links to sites that enable the illegal downloading of other people's content.

## Enforcement of durumis content policies

Reported content is not automatically deleted. The durumis team reviews reported content to determine whether it violates the community guidelines, and no action is taken for blogs or blog owners that do not violate the guidelines. If a blog is found to violate durumis' community guidelines, the platform takes one or more of the following actions based on the severity of the violation:

- Display a sensitive content warning notification on the blog or post.
- Cancel the publication of the post, making it accessible only to the blog author.
- Remove offensive content, blog posts, or the entire blog.
- Block access to the durumis account of the author.
- Block access to the durumis account of the author.
- Report the user to law enforcement agencies.

Additionally, if a user repeatedly engages in malicious behavior, durumis may take similar actions for multiple blogs created by that user. If a blog is suspended, creating an alternative blog for similar activities is not allowed.
