## **Summary**

Post-secondary institutions in British Columbia have relied on the tuition funds of international students to balance budgets for almost two decades.<sup>1</sup> International students experience discrimination and exclusion based on their various backgrounds while simultaneously putting billions into the economy and creating thousands of jobs.<sup>2</sup>

The gross inequality in the university experience and tuition fee increases between international and domestic students is not only unfair but potentially hazardous for British Columbia's economy. With international education so tied to economic growth, any decline in international enrolment could result in a sudden shock to British Columbia's economy and job market with far-reaching, disastrous effects.

## Rationale

The Alliance of BC Students has adopted these policy principles because:

- International students experience heightened discrimination and exclusion in comparison to domestic students:<sup>3</sup>
- International student tuition has risen 485% since 1991;<sup>4</sup>
- International student spending in 2022 translated to 79, 769 jobs throughout British Columbia;<sup>5</sup>
- The absence of limits to international student tuition increases create extreme financial uncertainty for international students;
- International students contributed \$3.5 billion to British Columbia's GDP in 2020;<sup>6</sup>
