

Abstract

It is strongly recommended you utilise the provided template and adhere closely to the directions while formatting your work in Microsoft Word. The abstract section is a narrative exposition that does not include any citations or references. The abstract is required to provide a concise and inclusive overview of the manuscript's objectives, substance, and findings, all within a word limit of 150 words. Please ensure that there are two blank lines before the "Abstract" section. Please format the text using 10-point Times New Roman font in italics and single spacing.

Keywords: Please provide a list of 3-5 keywords, separated by commas.

1. Introduction

The full-length paper should be sent by email. The purpose of the author rules is to ensure consistency in the manuscripts published in the journal. It is imperative to maintain consistency in the font, layout, and style employed during the preparation of your document. Kindly adhere to the prescribed styles outlined in the provided template and document in order to format your paper. English is the designated language of communication for the journal. The guidelines and complete paper template can be accessed in the Microsoft Word format. The article should include comprehensive information about the research conducted to ensure that readers are well-informed. The document ought to be organised into distinct sections, each accompanied by a clear header, in order to facilitate the reader's comprehension of the coherent progression of ideas. The submission of the paper's file must be conducted exclusively through the designated website, and it should be in Word format. Please note that PDF files will

not be considered valid submissions. Furthermore, it is crucial to name the file in accordance with the supplied reference number.

2. Content and Structure

Provide the following information.

- 1. The first page of the paper should include the following for double-blind review. this page should indicate authorship.
- Paper Title Author(s). The article should only mention author names in the biographical or reference list.
- Author(s) affiliations Author(s) addresses Author(s) email addresses

3. Camera-Ready Manuscript

The maximum allowable length for your paper should not exceed twelve pages. Please ensure that your camera-ready material is formatted in B5 size, which is 7.17 inches by 10.12 inches. It is requested that the paper size and pre-defined styles remain unaltered.

One recommended approach for formatting your manuscript is to utilise the Word template file (.doc) that can be obtained from the journal's website. Should you choose not to utilise this template, it is imperative that you adhere exactly to the directions outlined in this document for the purpose of formatting your paper. Alternatively, you may opt to employ the Full Paper Template given, making appropriate modifications to the text therein in order to accurately represent the content of your work.

3.1. Font Type, Styles and Sizes

Please use the **Times New Roman** font only and the attributes as mentioned below in Table 1.

The font sizes and font styles are associated with the pre-defined Template Styles. Use the pre-defined styles properly and do not modify or update the Styles.

3.2. Format

Your manuscript must fit within the required margins. In formatting your page (B5 size -7.17" x10.12"), set your margins at **3.17 cm** for top, bottom, and **2.54 cm** for left and right.

Do not use headers and footers and page numbers. They will be inserted and modified later.

3.3. Numbering and Attributing

Section titles should be numbered in Arabic.

Separate your article into logical, numbered paragraphs. The abstract is not included in the section numbering, and subsections should be numbered 1.1 (then 1.1.1, 1.1.2,...), 1.2, etc. Use these same numbers for internal citations; don't use "the text" when you mean anything else. Brief headings may be used for any section. It's best practise to give each heading its own line.

The heads of subsections should be italicised and numbered as displayed. The title of the document and section headings should be set in bold.

3.4. *Units*

Use the International System of Units (SI) only.

3.5. Figures and Tables




Figure 1: Insert the Figure Title

The placement of figure captions should be situated below the respective figures, as exemplified in Figure 1. Similarly, table captions should be positioned above the corresponding tables, as demonstrated in Table 1.

It is important to acknowledge that the journal proceedings printing will be produced with grayscale images. Please assess the legibility of your coloured figures once they have been printed in grayscale (black and white).

3.6. Abbreviations and Acronyms

Define acronyms and abbreviations the first time they appear in the text. Unless absolutely necessary, avoid using abbreviations in title tags.

3.7. Equations

Equations should be numbered consecutively, with the equation numbers included in brackets and aligned flush with the right margin. In academic writing, it is customary to italicise symbols that represent quantities and variables, while leaving function names and units in regular font. It is imperative to ensure that the symbols utilised in the equation have been explicitly defined prior to its presentation, or alternatively, their meanings are provided immediately after the equation.

$$f(x) = \sin(a) + \cos(b) \tag{1}$$

where, a = variable one and b = variable two.

4. Grammar, Style and Proof Reading

Kindly employ grammatically correct and refined language usage. The author bears the responsibility for identifying errors. Any manuscript that fails to adhere to the aforementioned instructions may be subject to return for required revisions prior to publication or may face rejection during the review process.

5. Review Process

All manuscripts undergo a rigorous process of peer review and are required to adhere to criteria of academic excellence. The editor will evaluate the submissions, and if they are not immediately rejected, they will undergo anonymous peer review. The manuscripts are submitted to two anonymous reviewers in order to provide a double-blind peer review procedure. It should be noted that referees are provided with either a hardcopy or a softcopy of the work, which does not include the name(s) of the author(s), their affiliation and email address, as well as any acknowledgments that may be there.

Based on the feedback provided by the referees, the editorial board will proceed with one of the following determinations:

- Accept the paper
- Reconsider the paper after addressed the recommended modifications
- Reject the paper

6. Conclusion

7. References

In accordance with academic conventions, it is recommended that references be included towards the conclusion of the article, arranged in the sequential order in which they are cited throughout the document. It is recommended that the font utilised be Times New Roman with a font size of 9. The heading "References" without a number should be formatted in 11-point Times New Roman font, with bold styling.

References in the main text should be cited in the square brackets [1]. Two references should be included together separated by comma [1,2], while three or more consecutive references should be indicated as follows [3–8].
