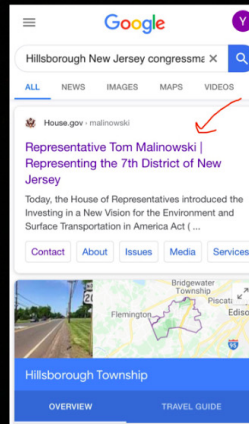
The Qualified Immunity Act is the shield that police officers get to hide behind, leaving them unaccountable for their actions.

In the case that a cop does act unlawfully, for example, murder an innocent unarmed man, he or she gets special protection from the supreme court.

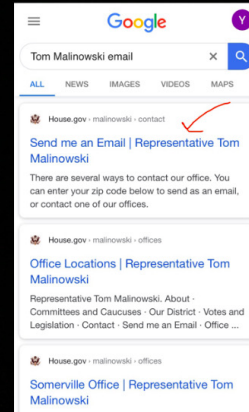
We NEED to do everything in our power to have this act abolished.
