



Founding Charter of the Ministry of Justice of the Republic of Checkland

Ratified by the Prime Minister and Cabinet of the Republic of Checkland on 06/14/2025

Preamble

In pursuit of liberty, order, and the rule of law within the Republic of Checkland, this Charter formally establishes the Ministry of Justice as a central institution of government. Guided by the principles of truth, responsibility, and constitutional integrity, this Ministry shall serve the Check people by ensuring the fair application of law, the defense of civil rights, and the maintenance of justice.

Article I: Establishment

1. There is hereby established a body of government known as the Ministry of Justice of the Republic of Checkland.
 2. The Ministry shall be a national-level institution reporting directly to the Prime Minister and working cooperatively with other Ministries as directed by law and executive order.

Article II: Mandate and Functions

The Ministry of Justice shall:

1. Oversee the judiciary of Checkland, including lower courts and the Supreme Court.
 2. Draft and maintain the Checkland Criminal Code, civil law guidelines, and procedural rules.
 3. Supervise the prosecution of crimes and the administration of legal justice.
 4. Support the appointment, training, and conduct of judges and court officials.
 5. Ensure access to justice for all citizens and residents, including public legal education where appropriate.
 6. Provide legal advice and support to other government departments upon request.
 7. Investigate internal legal misconduct and maintain judicial accountability.
 8. Maintain and publish legal documents, case records, and justice statistics.

Article III: Leadership and Structure

1. The Ministry shall be led by a Minister of Justice, appointed by the Prime Minister.
 2. The Minister may appoint Deputy Ministers, Directors, and Special Advisors as authorized by law.
 3. Internal divisions may include (but are not limited to):
 - Division of Courts and Judiciary
 - Division of Prosecutions
 - Division of Legal Affairs and Reform
 - Division of Corrections and Rehabilitation
 4. The Ministry shall operate within a budget allocated annually by the Ministry of Finance.

Article IV: Independence and Oversight

1. The Ministry shall act independently in its legal decisions, bound only by the Constitution and national law.
2. All decisions may be subject to judicial review or parliamentary inquiry.
3. The Ministry shall submit an Annual Report to the Prime Minister and Grand Assembly outlining:
 - Major case summaries
 - Budget usage
 - Reforms enacted
 - Institutional performance


Article V: Amendments

Amendments to this Charter may be made by:

1. A majority vote of the Grand Assembly; or
2. Executive decree by the Prime Minister, unless restricted by the Constitution.
