Body of Argument

Claim #1: Antonio acted courageously by attending a school that was linguistically and culturally different than anything he had previously experienced.

Criteria #1: Risked something of extraordinary value; his pride.

Evidence: After experiencing two embarrassing moments (being laughed at in front of the class and being laughed at for his lunch) Antonio almost "loses" it. ("A huge lump seemed to form in my throat and tears came to my eyes." "The pain and sadness seemed to spread to my soul, and I felt for the first time what the grown-ups call la triseta de la vida.")

Warrant: A courageous act requires that the individual risk something of value. In this case, Antonio risked his pride in attending a school where he did not speak the language nor was he knowledgeable about the customs. Antonio's father's pride in having the "Ilano" or plains as his school gave Antonio a similar pride in his background as a Chicano. For Antonio, being laughed at by the other students in his class damaged Antonio's perception of himself and his family. To endure this damage, this hurt, and carry on in school so that he could make his family proud, took courage on Antonio's part. A young-person without courage would have simply not returned to this school so that the pain and humiliation of having one's background misunderstood could be avoided altogether.

Criteria #2: He was aware of the risks even before entering the school building.

Evidence: "When I got to Main Street I was astounded. It seemed as if a million kids were shoutingruntingpushingcrying their way to school. For a long time I was held hypnotized by the thundering herd, then with a cry of resolution exploding from my throat I rushed into the melee."

Warrant: For an act to be courageous, the actor must be aware of the risks involved. In this case, Antonio was self-admittedly "hypnotized" by the huge numbers of children making their way to the school. Antonio was able to survey the scene before entering into the, as he calls it, "melee." Without courage, Antonio would have simply remained in that position as a bystander; or Antiono may have turned around and gone home. By using a fictitious word compounding several verbs, author Rudolfo Anaya creates the impression on readers that Antonio is aware of the many behaviors of the other children. A cry of "resolution" implies that, despite the risks involved, Antonio will continue his trek to school.

Evidence: "I wished for my mother, but I put away the thought because I knew I was expected to be a man." "But I knew that if I did I would shame my family name, that my mother's dream would crumble. I knew I had to grow up and be a man, but oh it was so very hard."

Warrant: A courageous act must be done for a noble purpose. Antonio's fortitude to remain in school comes not from a desire to "show up" the children who laughed at him, nor is it mindless compliance of doing it simply because his mother or father told him to. Even at the young age of seven, Antonio is able to make the connection that his remaining in school is done not for his own account rather it is done in the name of his family. To act on behalf of others is the core of nobility. To remain in school for another reason such as proving his toughness to the children who laughed at him, Antonio would

be acting on his own behalf - this is not courageous, it is selfish. However, by acting on behalf of his family, Antonio acts for them and not himself, which is noble and thus courageous.

For Antonio, being laughed at by the other students in his class damaged Antonio's perception of himself and his family.
