It is a software for simulating a live trading session, which does not require to fund an account.

So, Forex Tester Online is not a brokerage company or a platform, and it is not related to any existing companies, providing access to CFD, Stock or Crypto trading.

An affiliate can be provided with the exclusive 10% discount coupon for sharing via website or social media to engage the audience to buy Forex Tester Online.

Landing Page

The affiliate can create a unique landing page to attract more Forex Tester Online sales and get more commission.

But it is required to follow the rule regarding the prohibited usage of Forex Tester Online Branded Keywords for the advertisement.

Newsletter

Any affiliate is welcome to create a newsletter for the database of users, who had preliminary agreed to subscribe to any mailing.

Please, avoid spamming email with the branded name "Forex Tester Online" and the Company Website link.

Here's a list of the requirements:

1. Don't use false or misleading header information - your "From," "To," "Reply-To," and routing information – including the originating domain name and email address – must be accurate and identify the person or business who initiated the message.
2. Don't use deceptive subject lines - the subject line must accurately reflect the content of the message.
3. Identify the message as an ad - you must disclose clearly and conspicuously that your message is an advertisement.
4. Tell recipients where you're located - your message must include your valid physical postal address.
5. Tell recipients how to opt out of receiving future email from you – your email must include the «Unsubscribe» button.
6. Honor opt-out requests promptly - you must honor a recipient's opt-out request within 10 business days. You can't charge a fee, require the recipient to give you any personally identifying information beyond an email address, or make the recipient take any step other than sending a reply email or visiting a single page on an Internet website as a condition for honoring an opt-out request. Once people have told you they don't want to receive more messages from you, you can't sell or transfer their email addresses.
7. Monitor what others are doing on your behalf - even if you hire another company to handle your email marketing, you can't contract away your legal responsibility to comply with the laws. Both the company whose product is promoted in the message and the company that actually sends the message may be held legally responsible.

There is no regulation regarding the country of the user, who completed the affiliate purchase. The commission will be paid for any worldwide sale, except the Russian Federation and Republic of Belarus.

Please note that coupon websites are not eligible for approval and further collaboration.

FAQ

What to do in case of any doubts regarding the accuracy of affiliate link?

Firstly, you should write to promo@forextester.com so that we can check it. You need to indicate your affiliate ID and the place on your site where you want to insert your link. We also can make a test purchase.

You can find an appropriate affiliate link this way:

In your affiliate account, go to the “Text link” menu.

In the “Choose A Product Group” section, select a link suitable for your website.
