Personal Information:

Automatically Collected:

- Website usage data, IP addresses, browser information
- Text message delivery confirmations
- Email open and click rates

- Provide wedding ceremony services
- Communicate about your wedding and services
- Process payments and maintain records
- Send marketing communications (with consent)
- Improve our services and website
- Comply with legal requirements

INFORMATION SHARING

- Legal authorities if required by law
