Membership Report (Cynthia)

Treasurer's Report (Christian)

Will do report this annual meeting on finances. This will include the status of the year to date, through probably Jan, a statement of activity report, and a closing report of the last fiscal year. Need to complete the annual financial review in late April or early May. Would like to start recruiting a few members to participate.

Vice-President's Report (April)

-There are updates on a number of MOUs. Meeting with Lydia Alvarez Tuesday to discuss flex/academic calendar report regarding the best strategies to get information out and get feedback. Will meet with the District this week about the PT healthcare MOU, which is 1 year enhanced healthcare, and PTs would be able to opt-in. The District is getting pennies on the dollar now but would be able to get 50% back from the state. We are hopeful that the finalized MOU will happen this week. Have notified PTs who would meet eligibility for the enhanced program because they could submit paperwork for fall 2022. This is why that reimbursement has not

already been received. The CLI faculty MOU is to allow them to work 1 day remotely to avoid their having to come to work to do things they can do remotely. New BS program needs funding. PIH is hospital partnership with nursing, and we are waiting for the District to finalize their process with purchasing. District and CCFF agree on the sentiment and general language of the MOU.

Vice-President's Report (Mariam)
