Dear Clerk of Court,

Because my Lawyer of record, Jeff Toothacker, continues to violate Rules of Conduct 1.1, Competance, 1.2 Scope of Representation, 1.3 Diligence, 1.4 Communication, 4.1 Truthfulness in Statements to Others and 1.6 Prevent Bodily Harm or Death, I am forced to communicate with the Houlton District Court directly on matters of Law.

1. The first time I recieved the Docket Record directly from the Houlton District Court was this week. I have never recieved it from Shamara Bailey despite written demands and only from Jeff Toothacker my current lawyer of record in the last few weeks, depite demands in writing that all documents be provided to me by Jeff Toothacker months ago. The Docket Record revealed the following facts.

On 7/16/21 I was sent a notice to appear by the court, on 7/28/21 that notice was returned to the Houlton District Court as recorded in the docket record marked, UNDELIVERABLE by the USPS. Therefore the Court knew or reasonably should have known I was not notified per law to appear at the hearing on 9/7/21.

At this point the Court was legally obligated to have had the Aroostook Co. Sheriffs Dept serve me with the notice in person before the 9/7/21 hearing or have filed a continuance of the hearing until I had been legally notified in any other manner prior to the hearing. This would have given me a chance to consult counsel about my options for how to plea and provide bail. The court illegally failed to perform this legal requirement and in their arrogance, illegally held the hearing on 9/7/21 without my knowledge. At this hearing Judge Patrick Larson ruled I had Failed To Appear and issued an illegal Arrest Warrant. Because he knew or resonably should have known I had not been notified, as documented in the Docket Record, he had available to consult when I failed to appear because I had not been legally notified to appear. These actions by Judge Patrick Larson and the District Attourney violated my 14th amendment rights to Due Process (Fairness) and Equal Protection Before the Law. When the arrest warrant was executed by agency (Aroostook Co. Sherrifs Dept.) on 6/14/22, it was in fact legally FALSE ARRREST and FALSE INPRISONMENT, otherwise know as KIDNAPPING per Maine State Rule and Law.

1. I file the following motion concerning findings of fact and conclusions at law.

I demand, the Houlton District Court issue a Finding of Fact, I was not notified to appear as required by LAW, the hearing was illegally held and any rulings issues at the hearing were by Maine State Law illegal.

I demand the Houlton District Court Issue a Conclusion at Law, I have in Fact been kidnapped by the State of Maine because after my False Arrest and False imprisonment nothing the State of Maine did after that, was Legal including the arraignment hearing on 6/15/22.

All courts: Since you have responded to my informa pauperis pro se filing you have set a precedent and must continue to respond to all future informa pauperis pro se filing in future including suites for damages in Federal Court under ADA 1994 Law

I Cite the following as precedent.

The 1st amendment of the United States Constitution, Freedom of speach this includes my legal notes and all federal mail, Court records, medical records

The 14th amendment of the United States Constitution, Due process which means fairness. It is not fair to deny me evidence of false charges against me or deny me my written word which represents my freedom of speach in building a legal case for months.

When two laws conflict the one giving the citizen the greater protections shall be defered to.

Judges shall interpret the law in the simple language it is written in.

No police officer , jail, prison employee or judge may perform their duty and be a criminal at the same time which losses them all protections instantly as provided by their employment by the government if they behave in a criminal manner in the performance of their duties, opening them up to suites for damages under ADA 1994 Law in Federal Court, where all state protections vanish, no administrative rule or state statute overrules the supreme law of the land The United States Constitution and shall be over ruled by statute by any judge when found incorrect.

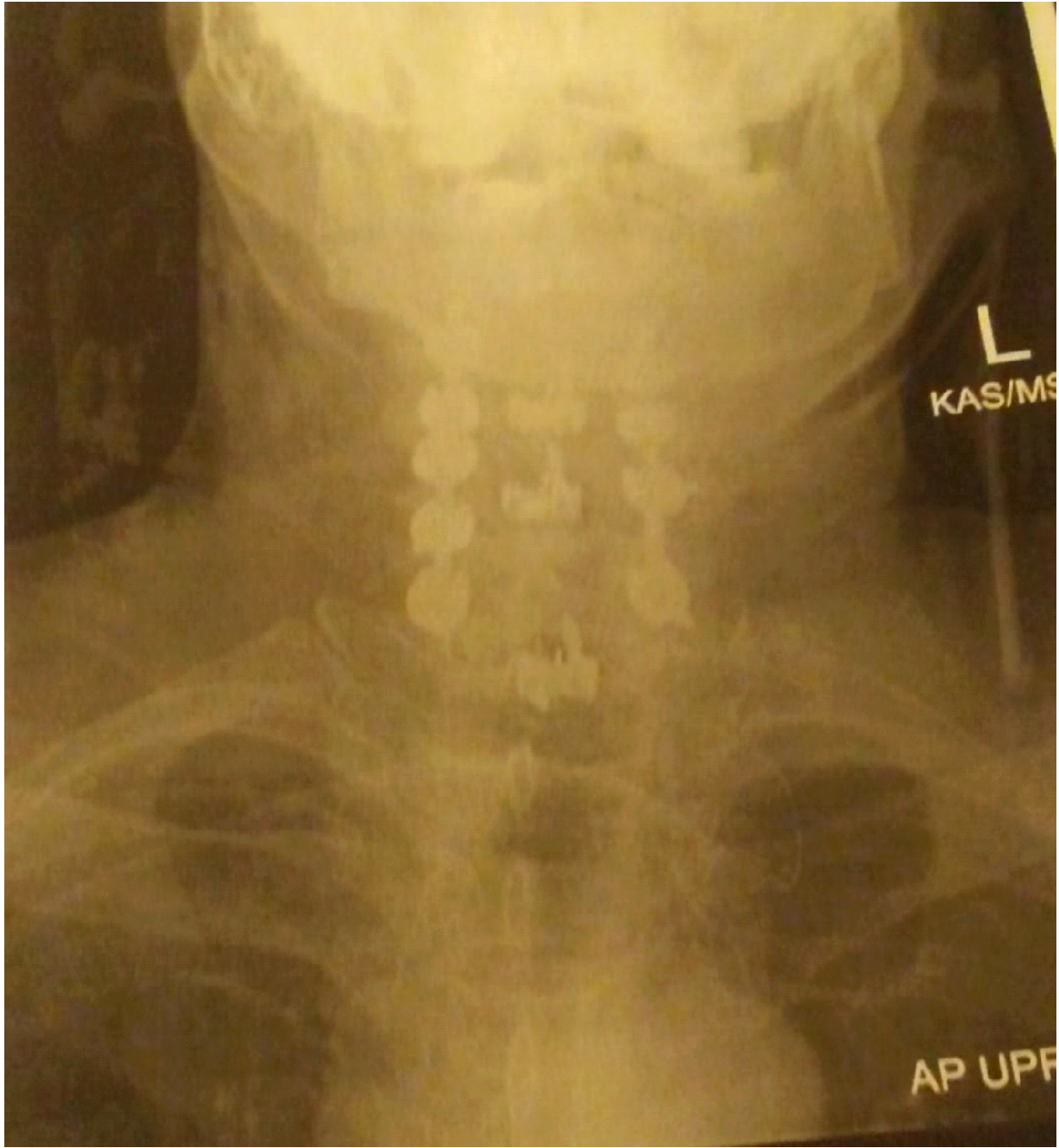
My given name is Timothy Peter Willard.
