

# TERMS OF USE

Last updated: November 6, 2019

These Terms of Use (“Terms”) govern your use of the TONOME mobile application (the “App”) and any related services provided through it.

By downloading, accessing, or using the App, you agree to be bound by these Terms. If you do not agree, you must not use the App.

## 1. GENERAL TERMS

TONOME provides tools for accounting and management of income and expenses.

The App may be used free of charge with limited functionality. Additional features may be available through paid subscriptions.

By starting to use TONOME, you confirm that you have read, understood, and accepted these Terms in full, without reservations.

Users located in the European Economic Area (EEA) may be required to provide explicit consent to these Terms and the Privacy Policy before using the App.

## 2. USER ACCOUNTS AND ACCESS

You may use certain features of TONOME without creating an account. Access to additional functionality may require registration.

When registering, you may be required to provide an email address and create login credentials. You are responsible for maintaining the confidentiality of your login information and for all activities performed under your account.

You agree to notify us immediately if you suspect any unauthorized access to your account or breach of security.

You may not copy, reproduce, sell, resell, or misuse TONOME or its components, nor attempt to interfere with the App’s operation.

We reserve the right to suspend or terminate accounts, restrict access to TONOME, or remove content at our discretion, including in cases of violation of these Terms.

Users under the age of 16 are not permitted to create an account. If it is determined that an account belongs to a user under 16, it may be deleted.

You may delete your account and stop using TONOME at any time by contacting support through the contact details provided within the App.

### **3. PAID SERVICES AND SUBSCRIPTIONS**

Certain features of TONOME may require a paid subscription (weekly, monthly, annual, or lifetime).

Subscription fees are charged in advance for the selected billing period. Pricing and subscription details are displayed within the App and may vary by region.

All payments are processed through the App Store. Subscription management, renewals, and cancellations are handled according to Apple's App Store rules and policies.

Refunds are subject to Apple's refund policy. We do not provide refunds directly.

By purchasing a subscription, you agree to the pricing, billing terms, and functionality provided at the time of purchase.

All content and materials available in TONOME, including but not limited to text, graphics, design elements, software, and databases, are protected by intellectual property laws.

You are granted a limited, non-exclusive, non-transferable license to use TONOME for personal, non-commercial purposes only.

TONOME is provided on an "as is" and "as available" basis, without warranties of any kind.

We do not guarantee that TONOME will meet your requirements, operate without interruptions, or be error-free.

To the maximum extent permitted by law, we are not liable for any direct, indirect, incidental, or consequential damages resulting from your use of TONOME.

## **6. CHANGES AND TERMINATION**

These Terms may be updated from time to time. Updated versions will be made available within the App.

Continued use of TONOME after changes are posted constitutes acceptance of the updated Terms.

If you do not agree with the updated Terms, you must stop using TONOME and may delete your account.

We reserve the right to suspend or discontinue TONOME or any part of it at any time.
