1. Introduction

(Times New Roman, 12pt, Bold)

Introduction contains background, formulation of the problem, objectives of the research/community service/critical literature review that describes the significant or the reason to do these activities, and relevancy to bibliographical coverage. State your purpose clearly within the first few paragraphs of the manuscript. If the reader cannot easily recognize what you hoped to accomplish in writing your manuscript for submission, it is likely to be rejected. (10pt, single line spacing, Times New Roman)

2. Method

Journal of Economic Empowerment Strategy (JEES) publishes original research paper, original community service paper and critical literature review (review paper). 5. Acknowledgments (Optional)

(Times New Roman, 12pt, Bold)

Insert acknowledgment, if any. The preferred spelling of the word “acknowledgment” in American English is without an “e” after the “g.” Use the singular heading even if you have many acknowledgments. Avoid expressions such as “One of us (S.B.A.) would like to thank” Instead, write “F. A. Author thanks” Sponsor and financial support acknowledgments are also placed here. **(10pt, single line spacing, Times New Roman)**

6. References

(Times New Roman, 12pt, Bold)

References only contain sources which are quoted on this paper with criteria as follows:

- a) Relevancy to the theme script
- b) Up to date (not more than 10 years)
- c) 60% references based on primary sources

Other Instruction:

The text must be in English and uses MSWORD software contain 6000 up to 8000 words. Authors whose English language is not their own are certainly requested to have their manuscripts checked (or co-authored) by an English native speaker, for linguistic correctness before submission and in its final version, if changes had been made to the initial version. The submitted typeset scripts of each contribution must be in their final form and of good appearance. The document you are reading is written in the format that should be used in your paper.

All document is set in 10pt Times New Roman. If absolutely necessary except title and subheading, we suggest the use of condensed line spacing rather than smaller point sizes.

The paper size is A4 with the margins are: 4 cm (left), 3 cm (right), 4 cm (top), and 3 cm (bottom).

1. Subheadings (Times New Roman, 11pt)

Subheadings should be as the above heading “2.1 Subheadings”. They should start at the left-hand margin on a separate line.

2. Tables and Figures (Times New Roman, 11pt)

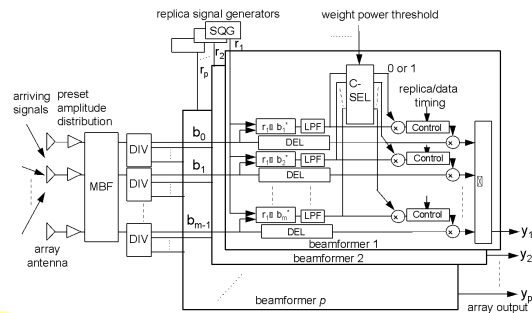


Figure 1. Proposed beam former
