Sub: **Issue directions to P(P=Principal Dr.Narasimha@Sultanpur campus) for the streamlining and regularizing of my services since 29Dec2022(28Dec2022=my relieving date at Manthani campus) and further onward through 4Jan2023(my joining report submission date@Sultanpur campus)**

Dear Sir,

Namaste. After I had been relieved in Manthani campus, I submitted my joining report(ref1) in JNTUHUCEs on 4Jan2023 F.N. and appraised your goodselves of the situation in person(ref2) in your chamber on 4Jan2023 evening i.e. on the same day. There is no gainsaying the fact that I submitted my joining report fulfilling conformingly the joining time provisions for the employees within the joining time bounds. Accordingly, subsequently, appropriately, your goodselves mentioned me in the procds. in refs(1&2) as in Sultanpur campus. That is the right service time profiling and right service streamlining in respect of me. Anything else that does not take into account that I am in service at Sultanpur campus is wrong. Please recall that I am the staff member (among both the teaching and nonteaching staff) whose services are despite the maximum no. of transfers experienced by me among all the teaching as well as nonteaching staff. I bore the travails and vicissitudes owing to the umpteen transfers in my service with great patient endurance. Please recall that I am the Professor with the maximum span of regular service among the CSE faculty.

I am an alumnus of Kukutpally campus for my B.Tech.(CSE) during 1985-89 and later of Masab Tank campus for my M.Tech. Further, I did Ph.D.(Software Engineering)@IITMadras, PostDoc@University of Jyväskylä, Finland and M.Sc.(Applied Psychology) at Chidambaram, Tamil Nadu. I was also trained by Indian Army@Officers Training Academy OTA, Kamptee, Maharashtra and Air Force Administrative College AFAC, Coimbatore. Thus, I am already of the most itinerant service by transfers for my academic services of 33 yrs. plus. Aptly, in view of my academic profile, JNTUH can gain the better repute by using my services for its foreign collaboration programs and students. But, neither are my services used for the development of NCC in JNTUH nor are they used for its foreign collaboration programs and students nor are they used, now, for the existing M.Tech. programs. Here and now, of late, perceptibly or imperceptibly, my service profile is under active evil abuse by the JNTUH authorities. I detail the active evil abuse as follows: I submitted my joining report in Sultanpur campus very well within the bounds of the joining time for regular faculty. Subsequently, I showed the refs.(3&4) to P and made him cognizant of it that both the refs. of the JNTUH higher authority mentioned me as of service at Sultanpur campus for BoS role assignment to me, but in vain. He derisively doggedly despicably neglected to have my name included in the faculty attendance register. Thus, he was contemptuous of the JNTUH higher authorities procds. refs(3&4). It is very annoying that this kind of an ill treatment of a kind hitherto unknown to me in any of the multifarious transfer times I have experienced in my pretty long service is meted out to me now.

On day-to-day basis, I appraised the higher authorities in person in the JNTUH H.Q. umpteen times as in the umpteen refs. above for streamlining and regularizing, by directions to P, my service in Sultanpur campus. Unfortunately, subsequent to the despicable neglect of P, my service in the JNTUH is at the cross roads. The university authorities became of erratic functioning so much so that it is crystal clear that the erratic functioning is now into a vicious cycle of maladministration. I have presented the situation to you quite explainingly such that you will endeavor duly immediately to recover the situation from the vicious cycle **by issuing directions to P for the streamlining and regularizing of my services since 4Jan2023, the date of my joining report submission@Sultanpur campus.**

Pathos has already crept into the employee-employer profiling in our univ. owing to the awfully badly prevailing circumstances. We, the employees, will be awesomely thankful to the higher authorities in the JNTUH H.Q., may the situation be well resolved immediately by efficacious administration (by directions to P) in lieu of maladministration and may it be seen that such circumstances do not recur. When the situation is rectified by information-transparent administration of rectitude, a case of an RTI application will not arise ever and turns needless thus winning the accolades of the employer-employee amity. The golden jubilee year of the univ. that is on the anvil turns to be of morbid turbidity (is it the gift of the JNTUH admn. to me, a 34-year alumnus?), if the administrative infamy of malpractices is to continue any longer.
