ELIGIBILITY CRITERIA

1. Applicant must be enrolled full-time or part-time in an associate degree program, a baccalaureate degree program or equivalent program.
2. Applicant must have a current 3.0 G.P.A. or better. (Not Cumulative GPA)
3. Applicant must be in financial need.
4. Applicant must be a graduate of the local high school of Salisbury borough.
5. Applicant must demonstrate personal responsibility and community involvement.

NOTICE TO ALL APPLICANTS
THE FOLLOWING MUST ACCOMPANY THIS APPLICATION

1. All letters of requests for financial aid for a given academic year
2. Letter of acceptance and high school transcript (1st semester freshman only) or transcript of most recent grades from the institution of higher learning. **(Official Transcripts Only)**
3. Copy of FAFSA if available – **MUST INCLUDE income figures!** If not, a copy of prior year's income tax return to establish family income or individual income tax return if financially independent
4. Copy of cost of tuition, room and board, books, fees, personal expenses/travel etc.
Account Summaries & estimates will not be accepted (We will only accept the actual bill showing the cost of tuition, room and board if applicable and any financial aid, scholarships or loans that have been applied to your account.
5. You may estimate the costs of books and list any **school related**, personal expenses incurred while attending school. If requesting mileage reimbursement, please, make your own calculations and enter a total amount.
6. Written statement by applicant to include community involvement activities, examples of personal responsibility, family and personal financial situation, and current academic standing.
7. Two letters of recommendation (1) one must be from a former teacher.
