Conclusion of Investigation into Michael Brooks (Hillary Bowers)

The Federal Bureau of Investigation concludes:

Introduction

At all times relevant to this Conclusion:

- 1. Defendent Michael Brooks (BROOKS) has participated for 2 days in TPON, actively running for mayor of Los Angeles, California. BROOKS joined on 11/17/2017.
- 2. BROOKS is suspected of participating in TPON despite being a banned member, who was banned for 1 month for use of an alternative account named "Hillary Bowers" (BOWERS), who used the alternative account "Jason Hamilton" (HAMILTON).

Relevant Individuals

- 3. FBI Agents noticed the similar speech style of BROOKS and BOWERS.
- 4. FBI Agents were aware and found it suspicious that BROOKS could maneuver himself well in TPON already.
- 5. FBI Agents took notice of the extremely similar logo styles (same fonts, same color schemes).
- 6. FBI Agents noticed a comment made by BROOKS in which he, probably by accident, commented his name as "Michael Bowers" on a post made by @g3tpon.
- 7. The FBI has requested the Secretary of Elections to confirm an IP match of BROOKS and BOWERS.

The Scheme

- 8. On November 17, 2017, BOWERS created an alternative TPON account by the name of BROOKS.
- 9. BOWERS is currently serving a one-month sentence for use of an alternative account by the name of HAMILTON. BOWERS plead guilty. The sentence is set to expire on December 6, 2017.
- 10. Instead of waiting out the sentence, BOWSER decided to create and use BROOKS.
- 11. BROOKS has been actively campaigning to be Mayor of Los Angeles, California, and has made 4 total posts.

Statutory Allegations and Recommended Charges

COUNT ONE

(Use of an alternative TPON personal account)

- 1. Paragraphs 1 through 11 are incorporated here.
- 2. From 11/17/2017 to 11/19/2017, BOWERS knowingly and intentionally created an alternative TPON account BROOKS.

COUNT TWO

(Violating sentence)

- 3. Paragraphs 1 through 11 are incorporated here.
- 4. From 11/17/2017 to 11/19/2017, BOWERS knowingly and intentionally violated his sentence of one-month through the use of the BROOKS account.

Conclusion of Investigation into Michael Brooks (Hillary Bowers)

The Federal Bureau of Investigation concludes:

Introduction

At all times relevant to this Conclusion:

- 5. Defendant Hillary Bowers (BOWERS) served as a Governor of the states of New Hampshire and New Jersey. BOWERS joined TPON on 6/14/2017.
- 6. BOWERS is suspected of use of an alternative account named "Jason Hamilton" (HAMILTON), which joined TPON on 10/13/2017 and subsequently disabled on 10/29/2017. HAMILTON served as a Governor of the state of Virginia.

Relevant Individuals

- 7. Dr. Jill Stein (STEIN), current Mayor of the District of Columbia, provided screenshots of a conversation with BOWERS showing BOWERS confessing to the ownership and use of an alternative account.
- 8. STEIN provided this information to the President of the United States, who turned it over to the Federal Bureau of Investigation (FBI).

- 9. Immediately after receival of this information, the FBI proceeded to check with individuals such as Secretary of Elections Trey Williamson (WILLIAMSON) for the purposes of IP-address-matching for the purposes of solidifying the claim and evidence.
- 10. WILLIAMSON found a vote belonging to BOWERS and his IP-address, but could not find a vote cast by HAMILTON.
- 11. TPON Historian George W. Morecraft (MORECRAFT) was contacted to provide the IP-address of HAMILTON based on recent surveys hosted by the Historian MORECRAFT.
- 12. The IPs of BOWERS and HAMILTON were found to match.

The Scheme

- 13. On the 13th of October, 2017, BOWERS created an Instagram account for TPON under the alias "Jason Hamilton" (HAMILTON).
- 14. BOWERS devised and intended to cheat the TPON game and processes by managing and owning more than one TPON-personal account, and help win elections for himself and possibly for others.
- 15. On the 29th of October, 2017 after engaging in a conversation with STEIN, BOWERS disabled the account HAMILTON in an attempt to evade capture.

Statutory Allegations and Recommended Charges

COUNT ONE

(Use of an Alternative TPON-Personal Account)

- 16. Paragraphs 1 through 11 are incorporated here.
- 17. From 10/13/2017 to 10/29/2017, BOWERS knowingly and intentionally created an alternative TPON account HAMILTON.
