Mayor Bland reconvened the meeting from the Special Meeting held at 5:30 PM. He asked that we stand for the Pledge of Allegiance.

The organizational meeting of the Spindale Board of Commissioners allowed four Commissioners to be sworn in. Mrs. Rosaleen Francis, newly elected Commissioner, along with Nancy Walker, James Hamilton and Glen Harmon, who are re-elected Commissioners took the oath of office. After the swearing in ceremony Commissioner Francis took her seat at the dais.

Approval of Minutes
