Terms and Conditions

Use of Facility

In consideration of participation in Holland Christian School's athletic clubs, clinics or leagues in this registration (supervised by a district employee). You agree that your child will be served by the staff for the activity you signed up for and agree to the following:

Liability Waiver

You agree to release and hold harmless Holland Christian Schools, its employees, administrators or board members, from any and all liability, claims, demands, damages, or expenses arising from or related to the use of the facility, whether caused by negligence or otherwise.

Image Consent

Holland Christian Schools may use images of your child during participation for promotional material. If you would like for your child to not be photographed, video taped, or appear in promotional material, please contact the athletic office.

Physical Consent

Your child is physically able to participate without restrictions in the activity that they are signed up for. You will inform the camp instructor of any health conditions or recurring illnesses that could cause a physical limitation for your child. You acknowledge the inherent physical risks associated with the activity your child is signed up for.

Concussion Awareness

You have read the linked information from the MDHHS and CDC. As a result, you understand the signs and symptoms of a concussion and will communicate any concern of a concussion with your child to the staff. All lead instructors are certified in concussion awareness.

Participation Fee & Potential Refund

A full refund (minus fees of \$10) will only be offered outside of two weeks prior to the activity beginning. This is also the same date when early bird pricing changes to regular pricing. The only exceptions to refunds inside of two weeks before the activity begins is for unforeseen medical reasons and will be considered by the camp instructor and the athletic director.

Consent to Treatment

In case of an emergency, every effort will be made to contact you as well as the emergency contacts provided. If the emergency contact cannot be reached and medical treatment is needed. I give permission for my child to receive medical treatment. I personally assume responsibility for expenses not covered by my insurance.

Responsibility

The renter agrees to indemnify and defend Holland Christian Schools from any claims, including attorney's fees, resulting from the renter's use of the premises.

You acknowledge your responsibility for legal liability imposed on you as a result of personal actions taken by your child during this activity. If your child is required to leave the activity, I acknowledge that you will not receive a refund.

The renter may be required to provide proof of general liability insurance naming Holland Christian Schools as additionally insured.
