A resolution for a revised Executive Committee was presented. The structure will include the 4 officers who serve two-year terms each and an additional 5th seat which will be filled by an at large TRLB member. This committee requires an in person quorum similar to the board. A motion was made by Brian and seconded by Kevin to approve this resolution. The resolution was approved. 8 Ayes, 0 Nays, O Absent.

Brian received bids for demolition and asbestos abatement for property at 216 Church in Jacksonville A motion to approve the acceptance of the low bids was made by Kevin and seconded by Ginny. The motion carried with a voice vote.
