

1. Deploing Vladimir Putin's ambition to overtake on the rightful sovereignty of Ukraine over its territory,
2. Pointing out the intolerable war in Ukraine being waged by Russia, led by Vladimir Putin, with Belarus, led by Alexander Lukashenko as an ally, killing civilians and creating conditions for genocide,

6. Drawing attention to the misappropriation of religious arguments to justify policies, war and human rights violations
7. 8. Aware of the ineffectiveness of previous treaties regarding cooperation in the East, such as Charter of the United Nations, Helsinki Final Act, the Charter of Paris for a New Europe, and the Budapest Memorandum.
9. Noting with deep concern the interference of Russia in (EU) political affairs by funding political parties promoting ideas of xenophobia and totalitarianism in member States
10. Taking into consideration serious differences in standards of living between EU countries and EU's neighbours, so that they have to choose between the EU and East for their development(needs to be modified)
