Reopening Plan - Building Level

CLARK ELEMENTARY



Students Arriving at School

Procedures and protocols, including the following:

- When will students be allowed in the building
 - Supervision will be in place for student arrival at 8:30 Tuesday through Friday and 9:30 on Monday. At this time, no early birds will be provided.
- Which doors will they use
 - K/1 playground doors, 4/5 Main Entrance, 2/3 West Side doors
 - K/1 will take their temperatures as they come inside the gates to the playground
- Do they go directly to class, stay on the playground until doors open, etc.
 - Kids will be outside for recess in the morning as long as the weather permits, when inside due to weather, students will wear masks
- Protocols for those who eat breakfast:
Current school morning plan will stay in effect.
Students will have their temperature taken when entering the front doors and will wear masks when in line. We will space the tables appropriately to allow for physical distancing.

Health Screening

Procedures and protocols, including:

- How will temperatures be taken to avoid students lining up at front doors.
 - As students line up, maintain social distancing as they await having their temperatures taken.
*K/1 will have their temperature taken at the gates upon arrival.
Sheets will be provided to highlight student names. 2-3 staff members will be part of the "Temperature Team" at each door.
 - Screening questions:
 - Do you have any of the following:
 - Headache
 - Body aches
 - Sore throat
 - New loss of taste/smell
 - chills/shaking with chills
 - Student temperature is >100.4 degrees

Identify team that will take temperatures and screen-Master Schedule

(Supply one thermometer per hall for use during the day)

During the Regular School Day

Transition Times: Procedures and protocols, including:

- Between periods or moving to specials
- If we can't physical distance, mask or face coverings will be worn

Lunch (Breakfast): Procedures and protocols, including:

11:40 2/3 2nd-A day, 3rd-B day

12:00 K A day

12:10 1st B day

12:15 4th A day

12:20 5th B day

Rotating A/B schedule for students eating in the cafeteria/classroom. Classrooms that will be eating in the classroom will be provided with a large garbage bag.

Identification of eating areas to provide physical distancing

Rotating schedule

Students will wear masks in line if they are eating in the cafeteria.

If they are eating in their classrooms, lunch will be delivered to the classroom.

- Work with custodian/teacher to disinfect classroom before/after lunch

Specials Procedures and protocols, including:

- Masks will be worn during transitions and then be worn at the discretion of the Specials teachers barring 6ft distancing

Students exiting school at the end of the day: Procedures and protocols, including:

- Which doors will they use, multiple exit doors recommended:
 - Students will wear their masks and exit through the front and back doors if they are being picked up
 - K/1 will dismiss students by their playground gates
 - Physical distancing standards while waiting for bus-Students will wear a mask in line waiting for the bus and riding the bus.

Staggered dismissal:

- Walkers and pick ups will be dismissed at 3:35 with the ECDC bus bell
- Bussers will be released at 3:40 and line up in the assigned areas

***Bathroom Usage will be scheduled with grade level/hallway teams.

***Require students to bring water bottles. Drinking fountains will be out of service

***No assemblies but will try to do it via Zoom/Google Meet

We will ask that students keep their "gaiter masks" at school and we will wash them throughout the week on a rotating basis. They will also need to have a personally owned mask that they wear to and from school.

UCSD #1 Virtual School Option

- K-5: Classroom Based Virtual School Model
 - District will allow off-site instruction and will be the virtual education provider for students who do not want to participate in face-to-face instruction for the 1st quarter of the 2020-21 school year:
 - Virtual instruction will focus on core content areas (Language Arts, Science, Mathematics, and Social Studies)
 - Students with special needs, including students who are medically fragile or have an existing IEP will have priority.
 - Teacher office hours and zoom activities will be scheduled between 4:00 p.m. and 7:00 p.m.
 - Students will be assigned an appropriate grade level teacher that will mirror the curriculum offered during instruction at school.
 - The number of sections offered will be determined by the number of students requesting virtual education at each grade level.
 - Virtual education programs and classes will be approved by WDE.
 - Wyoming certification require by all virtual teachers
 - Teachers will participate in the required professional development related to virtual education instruction during the 2020-21 school year.
 - Student attendance will be tracked at daily/weekly using the virtual education participation metrics.
 - The ability to provide a K-5 Virtual School option will be reviewed quarterly to determine if it is needed based on enrollment, the current health orders from Wyoming and Uinta County Public Health, and/or when district resources for the program have been exhausted.
 - During phase I of the District's reopening plan, students selecting the K -5 virtual option, and those who have selected homeschool will not be allowed to take face-to-face elementary classes (specials). This may change as state health orders are relaxed.
 - Students will be allowed to transfer from the K-5 virtual option to regular school (face-to-face instruction) at any time.
